### WEBB & CLARK SHARE CHAMBER OF COMMERCE NEWS

Washington County commerce is thriving! Perry Web and Steve Clark present the big picture at the June 5th Bar Meeting.

As the executive director of the Walnut Ridge and Forrest City Chambers of Commerce and in his current position as president and chief executive officer of the Springdale Chamber, Webb has worked in all facets of the business sector - from tourism, community and economic development to advertising, marketing and promotion. Under his direction the Chamber has led Springdale to record job creation levels, with over 16,000 jobs created since 1994.

Perry received his Certified Chamber Executive designation in 2004 from the American Chamber of Commerce Executives. Perry served as a member of the US Chamber's Institute for Organization Management's Board of Trustees, and was chairman of that national board in 2009. Previously he served two years as the chairman of the Curriculum Review Committee, and was a Institute faculty member for over fifteen years.

As an avocation, he found time to serve as a basketball and football official for more than 25 years. During that time, he refereed more than 2,500 basketball games and more than 400 football games. Starting in 1987, Webb also officiated NCAA Division I basketball.

Steve is a graduate of Arkansas State University and the University Of Arkansas School Of Law in Fayetteville. He is a distinguished alumnus of both schools.

Steve is a veteran. He served in the United States Army and Army Reserves as an infantry officer.

Prior to his service at the Chamber, Steve served five terms as the elected Attorney General of Arkansas, served as Chief of Staff to Governor David Pryor, served as a Municipal Judge in Brinkley Arkansas, and was a founder and president of a national behavioral health company, The InnerCare Group.

Steve has argued eight cases before the United States Supreme Court, winning five of those cases. Steve was chosen as the most outstanding Attorney General in the nation. The National Center for Missing and Exploited Children presented Steve with its National Child Protection Award.

Steve has served as a law professor at both of Arkansas' law schools, at South Texas College of Law in Houston,TX and at St. Thomas University School of Law in Miami, FL. Steve has also served as a legislative consultant to the United States Nuclear Waste Negotiator.

Steve is a member of the Northwest Arkansas Council, the Northwest Arkansas Council Strategic Steering Leadership Committee, the Board of Directors of Bikes, Blues and BBQ, the Board of Directors of the Walton Arts Center, the Advisory Board of the Yvonne Richardson Center, the Foundation Board of the Northwest Arkansas Community College, the Northwest Arkansas Workforce Investment Board, the Northwest Arkansas Economic Development Board and served on the City of Fayetteville's Town and Gown Committee. Steve currently serves on the Favetteville Police Departments Community Action Advisory Board. He is a Board Member of the Arkansas Good Roads Transportation Council. Steve is a member of the permanent teaching faculty for the Association of Certified Fraud Examiners.

Additionally, Steve is member of the Board of Regents of the United States Chamber of Commerce Foundation's Institute for Organization Management for the Northeast region serving as Chair of the Board. He also serves as a member of the advisory committee for the Institute for Economic Advancement at University of Arkansas Little Rock. Steve serves on the National Policy Council of the organization, Chambers in Innovation and Clean Energy.

Steve is married to Suzanne Clark, a chemical engineer and litigation attorney. Suzanne is President Elect of the Arkansas Bar Association. They have two daughters and five grandchildren.
