

City of New Munich
City Council Minutes

February 4th, 2019

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, Ron Doll and Elmer Boecker were present.

On a motion by Ron Doll, seconded by Elmer Boecker and carried the minutes from January 7th, 2019 were approved.

Fire Chief, Allen Fiedler was present to inform the Council on two medical calls last month. Allen submitted a few bills that need to be paid, Leedstone \$38.41 and Stearns County Fire chief's tickets \$30.00.

Waste/Water Operator, Tom Valerius was present to inform the Council that he submitted the Tier II Reports, he requested a check to be sent to State Dept of Public Safety. He noted that they flushed the hydrants last Saturday, while flushing the breaker blew for the pump. It hasn't been the first time since this has happened so we will be getting a quote to fix this issue.

Ann Piotrowski was present from the Jaycees, she requested a check for \$750.00 for a deposit for the music for the Fall Festival.

Roger Boecker from R-Way Pumping was present to submit a bill of \$2882.50 to be paid.

On a motion by Shawn Duevel, seconded by Ron Doll and carried the Resolution 1-19-A Notice of Polling Place for Year of 2019.

Residents have been concerned with the temperatures and pipes freezing, the City recommends that residents trickle their water to prevent pipes/water from freezing. We are asking the residents to call the City Hall to let the City Clerk if you are trickling the water. On a motion by Elmer Boecker, seconded by Shawn Duevel and carried the credit of \$5.00 per month to the resident to cover the water/sewer charges.

Fire Chief, Allen Fiedler mentioned he will follow the state process for doing background checks for all new fire department individuals.

A rental inspection was done at property 250 Liberty St (City owned) some items that needs to be corrected is 3 new smoke/CO detectors, fix the element in the water heater and install a railing for the steps on front entry.
