No bid may be considered unless accompanied by the required bid guarantee of 5% of the total bid amount which amount shall be forfeited if the bidder is awarded the Contract and fails to enter into a Contract with the Owners. Successful bidder will be required to provide payment and performance bonds in an amount of at least 100% of awarded contract price.

Contractors shall be required to submit proof of at least three years of experience in municipal water construction and sanitary sewer construction. The proof shall consist of at least three water projects and three sewer projects completed within the last three years, along with references for each project. Any specialty subcontractors shall be required to submit proof of experience of at least three years for the specialty work to be performed. The proof shall be submitted with the bid.

All bidders must comply with requirements for Bid Security in accordance with W,S. 15-1-113(f), and the Successful Bidder must comply with requirements for Contract Securities (Payment and Performance Bonds) in accordance with W.S. 15-1-

113(d) and (f) and W.S. 16-6-112.

A bid must be accompanied by Bid Security made payable to the Owner in the amount of five percent (5%) of the maximum Bid price in the form of a Bid Bond issued by a surety meeting the requirements of paragraphs 5.01 and 5.02 of the General Conditions for bids greater than \$150,000.
