To the Sherburn and Welcome City Councils,

The department logged 145 calls for service for the month of August. This brings the yearly total to 905 as of August 31. We are up substantially over previous years and it doesn't show any signs of slowing down.

The department's new web-site is currently being constructed with the intent to have it on-line by the end of October. The site will provide information about the department as well as contact information, department activities, other local agency contacts, ordinance information and many other items. I will keep you posted as to when it is available for viewing.

The department had department pictures taken at on September 6. Some of these photos will be used on the web-site as well as hung in our office in Sherburn. While many agencies do this every few years, this is the first time our department has done this. We should receive the proofs in late September.

E-charging training is completed and I anticipate that it will be operational in the department by the end of September. It is a lot to learn, but I think it will make filing complaints much more efficient. There is still no time line on when E-citation will go into operation.
