Meiselbach Park Accessible Recreation Improvements

LOCATION: Fred Meiselbach Park on Neuman Road near the corner with Bartlett Road, St. Clair Township

DESCRIPTION: This is a modified re-bidding of a project bid last September. Bids will be accepted for all or some of the following bid categories:

1. Furnishing and installing Universal Design playground equipment and poured-in-place playground surfacing that includes an impact layer made of recycled rubber
2. Construction of an approximately 500-foot asphalt walking path within the park
3. Furnishing and installing three (3) solar-powered LED lights and lampposts along the pathway

BID DUE DATE: Sealed proposals will be received by St. Clair Township at the Township Hall, 1539 Bartlett Road, St. Clair, Michigan 48079 until **11:00 AM on March 29, 2019**, at which time the bids will be publicly opened and read aloud. Bids will not be accepted or considered after this time.

FUNDING: This project is funded in part by a Michigan Recreation Passport Grant, so relevant state or federal requirements will apply; however, neither federal Davis-Bacon Wage Rates nor state Prevailing Wage Rates will apply to this project.

BID DOCUMENTS: Plans and specifications may be examined and obtained beginning February 26, 2019 at the St. Clair Township Hall. The project site nearby may also be examined at the same time. Electronic files of the bid documents can be obtained at no charge by contacting the Consultant. Copies of bid documents will be mailed for an additional fee, to be determined by the chosen method of delivery.

BID GUARANTEE: Each proposal must be accompanied by an acceptable bid security in the form of a certified check, cashier's check, or standard form bid bond, made payable to St. Clair Township, in the amount of not less than 5% of the base bid submitted. Failure of an accepted bidder to enter into a contract for the work will be cause for forfeit of the bid security. After contracts for the work have been signed, all bid securities will be returned.

RIGHTS OF THE OWNER: The Owner reserves the right to accept any proposal in whole or in part, to reject any or all proposals, and to waive defects in the proposals. Some scope items may be cancelled if all proposals exceed the available funding. Estimated quantities are not guaranteed and are solely for the purpose of comparison of proposals. Final payment for all Unit Price Proposal items will be based on actual quantities, determined as provided in the Contract Documents.
