CORRESPONDENCE FROM THE FISCAL OFFICER:

FIRE DEPARTMENT:

Fire Chief Golden reported for the month. Total runs for the month were 32 EMS runs and 12 Fire runs. Year to date total is 215 EMS and 54 Fire. Mutual aid – Amanda 6, Berne 9, and Lancaster 4. Fire department will be switching to new reporting software. Will save \$50 year and it is more user friendly. Chief Golden presented a proposal for a contract fire/ems service. Chief Golden will gather more information and submit at the next meeting.

OLD BUSINESS:

1. AEP with whom we have a RUMA with will be repairing the road this year. Spires Paving will be doing the work and will coordinate with the county and AEP.
2. Mr. Pat Marshall of Country Club Road is getting gas lines to his home and then onto lots that will be sold off. The Township has not heard back from Nate Wagner for setting up a RUMA. Trustee Ellinger motioned to table this business until a later date. Trustee Wolfe seconded the motion. All were in favor with 3 ayes and no negative votes, motion passed.
3. Trustee Ellinger motioned to pass a resolution prohibiting marijuana growing facilities within Hocking Township. Trustee Wolfe seconded the motion. Roll call vote Ellinger – Yes, Claypool – Yes, Wolfe – Yes. Motion approved.
4. Will be getting ready for FY17 paving bids. Trustees to run the roads on May 12, 2017 at 7:30am.

NEW BUSINESS:


1. RUMA for Intelliwave and right of away agreement is being taken care of.


