Joe Barbera mentioned that schools in the district were being updated. Theresa Ross would be retiring in January.

John Mannion, 50th senate district, a teacher, is running for office. He is recommended by NYSUT. It is important for the senate and legislature to have someone in office with a real life experience in the classroom. Volunteers are asked to help make calls Oct. 25, at the NYSUT office in E. Syracuse from 5-8 PM, and Nov. 5, at Vona's in Oswego from 4-8 PM to encourage people to vote. Calls will only be made to NYSUT members. Dana Balter is also a recommended Representative.

If the Republicans continue with the majority, we can expect the Affordable Care Act to be ended, along with benefits lost - lifetime caps, pre- existing conditions for our children and grandchildren. There would most probably be cuts in Social Security, Medicare, and Medicaid, regardless of the promises that some representatives have made.

If you are having difficulty having procedures covered by Health insurance, call Excellus.

We had a moment of silence for the passing of Emily Dennison.

Bill Spreter, Vote Cope representative, (former Hannibal teacher) spoke about the excessive testing given to students. There seemed to be an agreement on a permanent

moratorium on this testing, but it was linked to increased funding for 100 charter schools. It was not acceptable to us, because public schools would have lost funding. NYSUT is endorsing John Mannion for state senate. He is aware first hand of the difficulties students have with lengthy testing.

Dana Balter is also recommended by NYSUT. For a list of recommendations for November's election, check NYSUT.org.

We are all members of NYS Alliance for Retired Americans. They will have their next meeting on Friday, Nov.7 at 10 AM- noon at the NYSUT office on Brittonfield Parkway. All are welcome. Something to be aware of: Ryan and McConnell plan to cut Social Security, Medicare, and Medicaid to ease the deficit. (Remember, the tax cut that added to the deficit?) Note: These programs also cover children and adults with disabilities and veterans. Your vote in November is important.

The meeting was adjourned at 1:36 PM.
