2019 Shows - Year End Report 2019- Walter Mantler

There were 54 Sanctioned Shows in Canada in 2019 - That is up from 51 Shows in 2018

Manitoba had 7 - which is up from 4 in 2018  
Alberta had 4 - which is down from 7 in 2018  
Ontario had 28 - which is down from 30 in 2018  
Saskatchewan had 15 - which is up from 10 in 2018

We had some difficulty with some shows with regards to submissions of scores. Proper submissions of scores to 2 decimal points, supplying accurate membership numbers, remitting using proper spreadsheet and remitting within the proper time frame were the biggest problems. In order for WSDAC to track year end points proper submission practices need to take place.

Western Dressage in Canada continues to appear alive and well.

### WSDAC Membership

There were 190 members at the end of 2019, down from 202 at the end of 2018. (Attachment 1) There have been 84 renewals to January 21 for a renewal rate of 45%, compared to the 38% renewal rate by January 13, 2018, the date of last year's AGM. The 2019 renewal rate was 68%, the highest renewal rate to date. There were 55 new members in 2019. Ontario had the most members at 94 while Saskatchewan and Manitoba had 36 and 26 members respectively. Alberta followed with 19 members, British Columbia with 4 members, and Yukon with 5 members. Quebec had 2 members and New Brunswick had 1 member.

While memberships, both new and renewed, are automatically updated if paid by Paypal, memberships paid by e-transfer or cheque must be manually updated. It is very important to state on the e-transfer or cheque who the membership is for i.e. name and membership number would be appreciated.

### Horse Registry

The Horse Registry had 146 horses registered in 2015, 276 at the end of 2016, 340 at the end of 2017, 407 at the end of 2018, and 462 at the end of 2019 (Attachment 2). There have been no new horses registered in 2020 as of January 21.

The Membership Statistics and Horse Registry files are updated regularly on the WSDAC member website.

## Judges and Rules AGM Report 2019- Elaine Ward

Hello Members.

2019 has been a very successful year for WSDAC. With a record number of riders and WSDAC Sanctioned shows in Canada the growth of Western Dressage is on the rise.

With the advancement of the sport came several rule changes. I have attached the summary of the rule changes which was put on the member website, but I would like to also re-iterate them again. I encourage all competitors to read the 2020 rulebook. It is accessible on the WSDAC website.

Here is a condensed version of the rules that may affect you.

1. Half Chaps (Western Style) may be worn.
2. Although 4 tests are permitted to be ridden on each show day, it's the upmost responsibility of the rider to ensure the horse is fit enough to compete in all classes entered.
3. In addition to the use of metal snaffle bits, plastic and rubber coated bits are also permitted.
4. Letters SHOULD be placed 1 metre from the edge of the competition ring.
5. The guest judges card limit has been eliminated.
6. Competitors must be current WSDAC members at the time the scores were earned.
7. Hoof boots instead of horseshoes are permitted.
8. A protest rule and protocol has been initiated.

Again, I encourage all riders to read the rules before you enter the show arena.

The Judge rules remain the same for 2020. Judges that have either Provincial or National may apply for a WSDAC judge's status. As of 2020 the guest card rules have been rescinded. Please contact WSDAC directly for further information.

The viability of a National Judges school for 2020 may be discussed at a future date.

## **2019 National Points Program Report**

Throughout the year of 2019, A new member database has been created, tested and challenged. This will provide a simpler way to track and record national points for years to come. Thank you to all members and directors for patience and understanding while this system was being developed. A huge thank you to Mike Cornale for putting in the effort to make this happen.

National Points and Horse Performance Points have been updated with the results of all shows in 2019 and posted on the membership website. About 1573 show scores up to and including December 16<sup>th</sup>, 2019 have been entered in total. 93.4% of these scores were from horses in the Horse Performance program. There were 104 additional scores from non-members.

The National Points Program started in 2015 with 646 total rides. In 2019 we had 1573 total rides nationally. This is an astronomical increase of 118 % of number of rides over the span of 5 show seasons.

For the lifetime of the National Points program we have processed 5896 Total rides. 5461 of those rides are WSDAC members and part of the LHPP.

A total of 50 Horse Performance Certificates, and 6 Overall Awards have been issued in 2019. The LHPP will be integrated into the new database moving forward.
