Learn what our Members' Choice Candidates are doing and have done to make our union stronger

- Members' Choice candidates adamantly opposed the divisive contract extension that eliminated our pension and other hard-won benefits. We took our anger from that forced contract vote in 2014 and turned it into historic change that returned power to members and made our union stronger with passage of the Membership Bill of Rights on Sept. 6, 2016 – ensuring no such forced vote would ever occur again to IAM members.
- Hired a staff attorney so we could more aggressively represent the members.
- Stepped up contract enforcement; challenging Boeing in new ways using all legal avenues available, including demanding to bargain effects of changes in policy, filing Unfair Labor Practice charges, increased arbitrations and grievances, and more.
- Hold monthly webinars with union leaders during the pandemic on topics of importance to educate stewards to better represent members.
- Successfully challenged wage disparity issues in Boeing's hiring practices and delivered pay increases to more than 16,000 members, with many receiving back pay as well.
- Hold town hall meetings for candid two-way discussion for all shifts at halls close to where members work and live so it is easier to participate and provide input.

- Challenged Boeing's plan to eliminate thousands of inspections and hundreds of inspector jobs, resulting in a union committee to review and challenge these removals. Elevated our concerns to the FAA and continue to fight this issue to preserve the integrity of the build process.
- Hired Richard Aboulafia and the Teal Group to conduct an independent analysis on the best choice to site a new airplane program – comparing all 50 states in 41 different categories. Study showed Washington state is the most competitive place for large aerospace manufacturing operations (almost twice as good as the number 2 state) – the goal is to make it more difficult for Boeing to ignore statistics and facts.
- Offer yearly solidarity conferences with top leadership to educate and empower members for the future to strengthen our union.
- Offer union education classes so members know their rights and are better equipped to combat contract violations.
- Offer introduction to our union workshops so members can understand their rights, know our history and stand in solidarity with union members for a better future.
- Implemented new voting system to eliminate lines during contract votes.

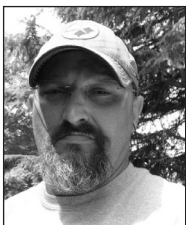

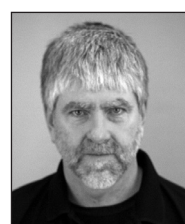
