CLOSING: Wednesday, February 17, 2021 at 6:00 PM EST, after which time entries cannot be accepted, cancelled, altered, or substituted.

DRAWING FOR ENTRIES: Wednesday, February 17, 2021 at 6:00 PM EST at the Test Secretary's address. In the event the published limit is exceeded, a drawing will be held at 6:00 pm, February 17, 2021 at 1105 Spring Street, Knoxville, TN 37934 and the public is invited. Entrants will be notified by phone or email promptly after the drawing is complete. Entries of AKC TD/TDU dogs will be accepted only if the test is not filled by dogs without said title.

IN THE EVENT AN ENTRANT IS ABSENT on the day of the test, it shall be the responsibility of the Test Secretary to determine if any alternates are present. If so, space will be filled by such in the order they were drawn. Entry fees and certifications will be returned within seven (7) days following the test for alternates who do not run and for entrants replaced by an alternate at the test.

ENTRY FEE: TD \$80 (includes \$3.50 AKC recording fee): 5 TD tracks offered.

All AKC recognized breeds and All American Dogs are eligible to enter this Test

Bitches in season MAY compete in accordance with Chapter 2, Section 8 of the AKC Tracking Regulations

DRAW FOR RUNNING ORDER OF TRACKS

The draw for running order of tracks will be held at Woodward Farm at 8:30 am central standard time. First TD track will be run as soon thereafter as the track is ready.

DIRECTIONS

TEST SITE: From I-24 North. Take exit 81A / US 231 South toward Shelbyville for approximately 24 miles. (US 231 will make a couple of turns through Shelbyville). Turn Right on TN 64 for 15 miles. Turn Right on Hunter Road for 1.5 miles. Bear Right at the fork onto Palmetto Cemetery Road. 1st house on the left.

From I-24 South. Take exit 97/TN 64 turning Left at the bottom of the ramp toward Shelbyville for 15 miles. Turn Right on 41A for 3.5 miles. Turn Left on 231 South through Shelbyville. Turn Right on Hunter Road for 1.5 miles. Bear Right at the fork onto Palmetto Cemetery Road. 1st house on the left.

RIBBONS AND AWARDS

A title ribbon will be awarded to each entrant passing the TD test.

IMPORTANT INFORMATION FOR EXHIBITORS

- **Please make checks out to ORKC (Oak Ridge Kennel Club).** A returned check charge of \$25.00 will be levied against an exhibitor and entry will be rejected for any check that is returned for insufficient funds.
- **CERTIFICATION.** A written certification must accompany each entry for any dog that has not previously passed an AKC TD or TDU test. This statement must be dated within two years of the date the test is to be held, signed by either a person approved to judge tracking tests, or by a person/evaluator who has handled a dog to a TDX or VST title within the last ten (10) years, and must certify that the dog has satisfactorily performed a certification track.
- **ENTRIES** will be accepted only on official AKC entry forms.
