Miscellaneous: This agreement shall become effective on the date signed below and will remain in effect until all responsibilities set out are fulfilled. The parties acknowledge that they will use their best good faith efforts to negotiate and resolve subsequent issues that may arise from this Agreement because of unforeseen occurrences and that may alter the conditions of this Agreement.

Cancellation Policy: This agreement is effective as of the date signed below and shall remain effective until the Expo ends on the 20th of January 2019 or until terminated by either party. All requests for refunds must be in writing, received and confirmed by Florida Agriculture and Wildlife Expo, Inc. 60 days prior to the event. Contracts cancelled up to 60 days of the event will be issued a refund based on a prorated basis. Florida Agriculture and Wildlife Expo, Inc. may terminate this agreement at any time by notifying the Partner in writing or by e-mail. Upon such termination, Florida Agriculture and Wildlife Expo, Inc. shall return to the Partner that portion of the Partnership fee pro-rated for the time remaining in the contract.
