Minutes of December 20, 2021

The Huntington Township Trustees met in regular scheduled session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Robert Holmes. Also present were Walter Rollin, Jed Lamb, Matt Combs, Frances Rollin, John Murphy and Sheila Lanning. Motion by Lamb with a second by Rollin to approve the minutes of the regular scheduled meeting of December 6, 2021 as written. Roll call: three yeas. Checks 9776-9789 and payments totaling \$21,528.19 approved for payment.

COMMITTEE REPORTS:

WATER BOARD- Lamb: missed the meeting, heard they gave raises and 6% for Manager.

LORCO- Lamb: did not make the meeting.

AMBULANCE- Holmes: Year to date runs in Huntington are 139, November runs to Huntington 17 with 12 responding from the Huntington satellite. All runs year to date are 1611. Problems with staffing weekends and Holidays. Looking into incentives to work.

FIRE- Rollin: Looking to replace #152 brush fire truck. Going through government buying.

SWAC- Lanning: received mini grant \$3,350.00 for culvert #656. Lamb: contacted ODOT and changed the contact name from Dennis Finkel.

ZONING BUSINESS/NEWS- Holmes: due to the passing of the Zoning Inspector Dennis Finkel, suggest putting 3 each zoning violations for shipping containers within the Township on hold till 2022. Lamb: add another container to the list, Mr. Kidney on Hawley and New London Eastern.

CEMETERY- Lanning: Tiffany Sexton called asking about the status of a foundation for her father William Sexton #115 West Cemetery. No foundation order received, asked Tiffany to contact the monument company and check. Szynal: need soil and seed by Travis Sexton plot if anyone asks.

ROADS and EQUIPMENT: Combs: graded Pratt Road but Stewart was too wet to grade.

RECYCLING- Holmes: looking good. Lamb: dropped off a filing cabinet that Combs secured with a lock for holding the money. Recycling will be closed on Christmas. Lamb: opened Saturday for oil and bulk stuff.

EMPLOYEES- *Motion* by Lamb with a second by Rollin to authorize a payout of all Dennis Finkel's salary and benefits. Roll call: three yeas. Discussion on buying Finkel's tools at the Township upon his passing. Combs: aware of some things but might not know all the items that belong to him. Lamb: Township needs to pay Lyn Ickes for all of Dennis Finkel's items. Holmes: will make a list and talk to Lyn, talked to Dennis when he was hospitalized and he said to ask Matt Combs.

PREVIOUS BUSINESS:

NEW BUSINESS:

Holmes: Finkel did not want anything after his passing, Lyn looking at maybe a memorial in the summer at the Eagles. John Murphy: Lyn Ickes did not want anything on Facebook beyond what is already there. Catalytic converters being cut from vehicles, an attempt on Hawley and 162 was stopped by the tenant/owner.
