The City Council of the City of New Munich met in regular session at 6:30 p.m. in the City Hall. Jim Poepping, Shawn Duevel, Ron Doll, Elmer Boecker and Pat Nathe were present.

On a motion by Ron Doll, seconded by Shawn Duevel and carried the minutes from August 2020 were approved. Motion carried.

Allen Fielder was present to inform the Council of no medical call for the past month. Al noted we received grant money from MBFTE - Minnesota Board of Firefighter Training and Education for \$3,500 and \$200 per firefighter. Al presented one bill to be paid for Med Compass.

Tom Valerius, Water/Waste Water Operator informed the Council that a mop head was found in the lift station pump this month, he wants the residents to be very careful on what goes down the drains to prevent damage to the pumps. The water tower was back online on August 20th, all test came back good.

Tom wants to thank everyone that was involved in the water tower project, it went smooth with everyone's help.

Ann Piotrowski from the Jaycees presented bills to be paid for the garage sale advertisements in town.

On a motion by Shawn Duevel, seconded by Ron Doll and carried Resolution 9-20-A (Budget) was approved. Motion carried.

Oak Electric quoted us \$4,850 to replace the lighting in City Hall and Fire Hall, council made a motion by Shawn Duevel, seconded by Elmer Boecker. Motion carried.

On a motion by Ron Doll, seconded by Shawn Duevel, carried, and approved the Declaration for Munich Acres. Motion carried.

The City Clerk gave her resignation. Ann Piotrowski (which is currently Treasurer), will be City Clerk and Stacy Funk will become Treasurer. Stacy will train Ann thru year end and any other training. Pat Nathe made a motion, seconded by Elmer Boecker. Motion carried.
