General Meeting Minutes

July 9, 2020

Board Attendees: Tony McClure, Don Spearing, Cal Roberts, Daisy Stone, Vic Gurinowitsch, Dan Charles & Mike Wyckoff.

Secretary's Report: Daisy Stone read the minutes from the June 11, 2020 meeting and a motion was passed approving it.

Treasurer's Report: Cal Roberts read the treasurer's report and a motion was passed approving it. Cal also reported that we received a very nice thank you card and handwritten letter from the kids for our donation to the Hunt of a Lifetime organization and that we have an outstanding check from our donation to the Boy Scouts in Honor of Paul Geisler.

Membership Report: Mike Wyckoff provided a membership report: 198 Social Members, 16 Voting Members and 9 Board of Directors for a total of 223 of the 250. We also have 31 Life Members, 2 Honorary Members and 7 Youth Members for a total of 263.

Unfinished Business:

- Dan Charles reported that the timber bids were supposed to be in by June 5 but this was delayed due being quarantined because of the Spotted Lantern Fly. The tentative schedule now is bids out in Sept, we'll meet to pick a company, start in Oct and finish by Nov. We should get roughly 2 payments of \$50,000 each. We are on hold until the quarantine is lifted.
- Dan Charles announced the Fishing Derby is August 8, 2020 at 9:00 AM with the Club Picnic starting at 1:00. It is all free but kids can register on our website so we have a headcount. All kids get a present and its for ages 18 and under.
- Tony McClure stated that at the last meeting Andy Theodore brought up a concern about hunting on club property. The BOD's are discussing this and will have a memo to present at the next meeting.

New Business:

- Don Spearing mentioned we are getting bids for concrete stairs down to the long range with railings.
- Dan Charles stated that work day is Saturday @ 9:00 AM and there will be coffee & donuts with the possibility of pizza or hoagies for lunch. The work that needs completed is clean out the lake for the fishing derby, finish cleaning out the archery building and build a pillar under the bridge for to the trap range. Tony McClure plans on bringing down the TV we are purchasing to be hung.

Bylaw Changes:

- Daisy Stone completed the second reading of the bylaw change submitted by the Board of Directors. This change included: Adding page numbers to all pages, Adding a Table of Contents prior to Article 1, Adding that Officers and BOD are Voting Members but are not required to pay dues (Article 4), Removing the No Guests section and adding wording and rules to permit guests (Article 4), Adding that the Executive Board and BOD do not pay dues (Article 6), setting a limit the BOD can donate to not exceed \$200.00 and designating whom is on the financial accounts (Article 9). Sharon Lynch asked for clarification on whether guest limit was 3 in your lifetime or 3 per year. The rule will be clarified that it is a lifetime max of 3 visits. A motion was made & passed approving this bylaw change.

Remarks:

- Vic Gurinowitsch provided a few printouts to help reduce confusion concerning the virus.
- Dan Charles mentioned that he was down here twice and the gate was locked with someone down range. One person had signed in the other had not. Do not lock the gate when at the club, you can close it but it must be left unlocked for emergency personnel.
- Dan Charles announced that we are selling a wood burning stove similar to the one in the club house but a little smaller. Please make offers.
