VILLAGE OF DRYDEN REGULAR MEETING LAMB MEMORIAL BUILDING October 4th, 2011

President, Betcher called the meeting to order at 7:00 P.M.

Pledge of Allegiance: President Betcher led the Pledge of Allegiance to the flag.

MOTION by Roszczewski, supported by Nash, to approve the September 6th, 2011 meeting minutes as presented.

Council voiced all ayes, Motion carried 5-0.

Public Comments:

Dryden Police Chief, Larry Pack stated that Saturday night at Dryden Fall Fest went good. There was only one arrest for operating while under the influence of drugs and a noise complaint received from someone on Meadow Lane. He also stated that the parking problem in the village has been solved.

Lapeer County Commissioner, Linda Jarvis stated that Torzewski and General Squire Water Parks will remain open next year and presented council with a budget proposal for both parks.

Property Owner, Justin Evans asked a question how the village handles sidewalks when there are bad. He explained that the sidewalk in front of Bishops house needs to be fixed and the bushes are grown over.

MOTION by Nash, supported by Quail, to approve the October 4th, 2011 agenda as presented.

Council voiced all ayes, Motion carried 6-0.

Treasurer, Rande Listerman gave a summary of the 2011 village property tax collections.

MOTION by Roszczewski, supported by Quail, to approve revised October 2011 Bills to Pay in the amount of \$ 14,425.63 and to accept September 2011 Disbursements in the amount of \$ 93194.57 as attached.

 Council reviewed the attached proposal from Penny Millikin regarding renting or purchasing two storage shed buildings to store village equipment.

President Betcher suggested that the village look at potential locations to build a new pole barn.

A request was made by council that the DPW Supervisor, John Ihrke get pricing to present at next month's meeting for a steel roof for the Lamb Memorial Building.

Trustee, Stan Roszczewski asked for approval from council to have the wedding ceremony of a family member that is taking place in the Mount Pleasant Cemetery on October 30th moved from the stairway to the grave sites over by their grandparents. He stated that there would be a small wedding service with about 8 to 10 people. Council instructed DPW Supervisor, John Ihrke to mark off the section off caution tape out of respect for other grave sites near the location.
