The Prison Rape Elimination Act (PREA) of 2003 is a federal law established to support the elimination and prevention of sexual assault and sexual misconduct in correctional systems. The Southside Regional Jail supports the guidelines set forth in this law and has ZERO-TOLERANCE for any and all incidents of sexual assault, sexual harassment and sexual misconduct.

This report provides a summary of incidents from January 1, 2016 through December 31, 2016 and will be utilized by the PREA Coordinator and PREA Compliance Manager to identify problem areas and formulate corrective measures in efforts of reducing future incidents.

In accordance with PREA, all investigations are assigned one of three possible determinations:

Substantiated: an allegation which was investigated and determined to have occurred.

Unsubstantiated: an allegation which provided insufficient evidence to make a final determination of a substantiated or unfounded claim.

Unfounded: an allegation which was investigated and determined not to have occurred.

The chart below provides the annual results. No problem areas were identified and no corrective measures needed at this time.

Southside Regional Jail makes every effort for reducing and/or eliminating sexual abuse and sexual harassment. This will be done by continuous inmate education along with staff training. Southside Regional Jail will be scheduled for an audit June 28 – 30, 2017.

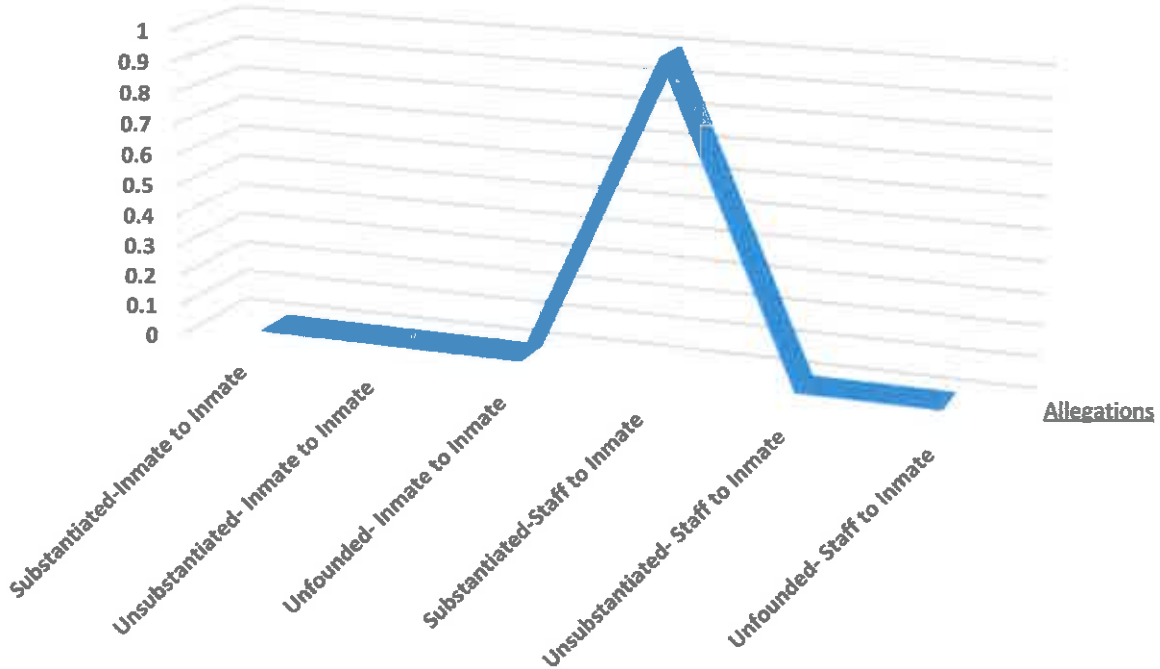
