## Events:

**License to Carry (LTC) Practice:** These are held every other Thursday night from 6:00 to 8:00 PM. The next dates for the July 18 and Aug 1. Daytime LTC practice on Tuesday July 1 at 9:00 AM. The participants get the opportunity to practice drawing from their concealment with their everyday carry pistols. All participants are closely monitored to provide a safe and fun atmosphere. There are multiple scenarios and barricades to practice various aspects of defending oneself if the situation ever presents itself.

**Action Pistol:** Practices and holds their events every other Wednesday starting at 6:00 PM. The next one will be on Wednesday the July 24.

**TPPC Member Only Action Pistol:** This event is for members only on Monday Aug 12 starting at 6:00 PM. **This is now a club shooting competition event.**

There will be a safety briefing, then shooting in the range. Free for members, \$5 for non-members. You may bring your gun, or there will also be pistols and ammo available for use. Minors above 12 years of age are welcome while accompanied by an adult.

### Final Thoughts

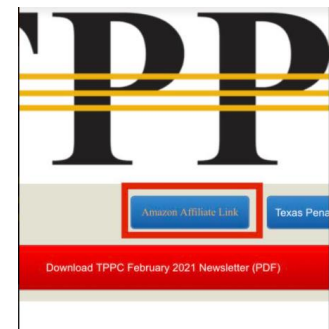

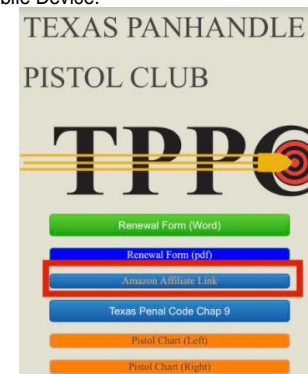

## NRA Armed Citizen from June 2024 Magazine

A 28-year-old alleged burglar is in the hospital after encountering an armed homeowner in Coos Bay, Ore.

At 1 in the morning on April 12, police received a call from a local resident, asking for police and medics to aid a man who had been shot inside the home. When officers arrived, they discovered the wounded man had attempted to break into the house and was armed with a golf club. The resident fired at the intruder, wounding him.

Officers provided care for the wounded intruder until paramedics arrived and transported him to a local hospital. Police say the resident and the alleged intruder did not know each other. The Supreme Court issued an "Order List" denying hearings on all cases that could be impacted by the recent Rahimi ruling regarding prohibited persons and sending back all the 922(g) cases to lower courts for further consideration. While this may seem like a setback, Smith believes it's not necessarily bad news. He highlights that these decisions are part of a larger strategy by the Court.

While the recent Supreme Court decisions might seem like a pause in Second Amendment progress, Smith reassures that it's part of a broader, strategic approach. The focus remains on building strong cases with sympathetic plaintiffs to secure favorable rulings in the long run.

## [AMERICANS BOUGHT OVER 1 MILLION GUNS EVERY MONTH FOR 59 IN A ROW](#)

According to data based on federal background checks for likely over-the-counter gun sales, last month was the 59th in a row where such checks soared past the 1-million mark. Holding the figure is quickly becoming the lasting goalpost in terms of America's firearm purchasing appetite.

The tally was verified by the National Shooting Sports Foundation by sorting the released data for the Federal Bureau of Investigation's National Instant Criminal Background Check System for last month. The unadjusted June 2024 FBI NICS figure of 1,958,447 – after the figures were combed by NSSF to remove checks and rechecks for carry permits – remains at 1,059,037 likely sales.

"June's pace of background checks remained steady with another month of more than 1 million background checks for the sale of a firearm at retail," Mark Oliva, NSSF's director of public affairs, told Guns.com in an email. "That brings the streak to 59 months of Americans, quite literally by the millions, choosing to exercise their Second Amendment rights by first freely approaching the gun counter to legally purchase a firearm. That is a steady signal from America as we approach election season that the right to keep and bear arms matters to law-abiding citizens."
