Doc: We are $\sim 25 \%$ into the new year. Expenditures @ $11 \%$. Money is coming in slow. Sales tax at 24\% Miscellaneous Revenue?
Scott: Covid-19 revenue. We may need to reclassify 10-335-0000 as Community Policing.
Incoming revenue is close to last year, so that is better than expected.
Doc: Unrestricted Funds @ \$3,909,263.08 and Restricted Funds @\$776,058.56 for a Grand Total Fund Balance of $\$ 4,685,321.64$.

## 3. CENSUS 2020 DISCUSSION

Doc: the census count is way down. Only 64.4 \% have responded. That equates to $\$ 1600$ per person per year. Scott said it would affect negatively the amount of Powell Bill money we receive.
Wesley: We should host and sponsor an open forum.
Caroline Jones: There is a census taker in town or you can sign up online at the library.
Doc: We could do it in TCP at the gazebo.
Scott: The County operates the census.
Wesley: Surely a census worker would come. I'll call and line something up and get back to Scott.

## 4. MEETING SPACE GOING FORWARD

Doc: October will be cooler. Might be time to move indoors.
Booe House, Town Hall or virtual.
Council, any thoughts?
Scott: We can have 25 in the Booe House. Council can limit the number allowed into the meeting. We don't have any Public Hearings coming up. We have a UDO Text Amendment for mobile homes coming in November or December.

Council is in agreement to have the 10/8 workshop in TCP and the 10/22 Town Council meeting in the Booe House.
