Opening Your New 'Home' Business

In the City Limits

The Occupational License Tax is a tax imposed on each person pursuing or conducting a trade, profession, vocation, calling or business within the municipality of Denham Springs. Under the Louisiana Constitution and laws of the state of Louisiana, guidelines are set on classification and rates for a business commencing after the first day of January of any calendar year.

Each person is required to keep reasonable records. Separate records are required for each place of business.

For legal clarification of tax liabilities and filing requirements refer to Chapter 3 of Title 47 of the Louisiana Revised Statutes of 1950.

Section 2.11 Home Occupation Permitted

occupations will be permitted district which dwellings Home in any in permitted with the following provisions and limitations: A Home Occupation is defined as an accessory of residential structure for a occupation or profession which:

- 2.11.1 Is engaged only by a member of the family occupying the premises. Only one person not resident of the household may be employed in the business to be conducted at the premises.
- <u>2.11.2</u> Is in respect to the residential site, conducted entirely within the dwelling.
- <u>2.11.3</u> Does not occupy more than twenty percent (20%) of the gross floor area of the dwelling.
- 2.11.4 Does not require any special entrance into the structure.
- <u>211.5</u> Has no exterior evidence of the accessory use, except for a nonilluminated sign no larger than one (1) square foot in area.
- <u>2.11.6</u> Mechanical equipment, air conditioning and heating used, shall be only that normally used in, or found in, a single family dwelling.
- <u>2.11.7</u> No home occupation shall be permitted which creates a need for more than three (3) parking spaces at any given time in addition to the required spaces for the dwelling unit.
- 2.11.8 activity resulting in traffic, noise, light, fumes and odors to such extent that it is noticeable that the property is being used for nonresidential purposes, shall not constitute a home occupation.
- In general, the following uses will be allowed as a home occupation; custom and dressmaking, millinery, tailoring, sewing of custom apparel custom home furnishing, laundering ironing, fine and arts studio, offices for professionals, child day care with no more than three (3) children accordance with State Laws and regulations; tutoring with not more than four simultaneously, and in general such other activities that conflict with other sections of this ordinance.

- 2.11.10 No home occupation shall be permitted in any accessory structure.

Attention: All Prospective Business Owners and Occupational License Holders

Do you and/or your business intend to purchase any items from "walk-in" customers who enter your business in hopes of selling you something? If the answer is "Yes", please inquire with the Business License Department about a "SecondHand Dealer's License". This license is required of all individuals and businesses who intend to purchase "ANY" item that is brought to them and offered for sale by a "walk-in" customer. Pursuant to LA RS 37:1869, failure to comply with these laws can result in Arrest, Incarceration, Fines and the Suspension of your Business

License....so protect yourself, your employees and your business.

Once you have received your "Secondhand Dealer's License" please contact the Denham Springs Police Department, to set up an appointment to ensure you are following all of the laws prior to conducting any business.
