- This membership does not in no way confer any ownership or liability to the Ridgewood Club property or its assets. By submitting your membership application, you (the applicant) fully understand there are risks inherent to the use of the Club facility by its nature, and are willing to assume those risks for yourself (and your family) if applicable.
- Please note that the amount of dues for each category of membership is subject to change from time to time and as set forth in the Membership Rules and Regulations Handbook.
- Members are obligated to keep a valid approved credit card on file with Ridgewood Club at all times. All Dues, Fees, and charges for events, merchandise, and services of the Ridgewood Club incurred by you, your family and your guests will be charged to your credit card if not paid in cash, at the time services are rendered and that you are responsible for all amounts that are not paid by the credit card company.
- All dues are non-refundable after the billing dates. Also, understand that the monthly and quarterly dues will be automatically billed to your Credit Card unless paid in full. Ridgewood Club reserves the right to levy any late fees as well as returned check fees. (Please note that the fees are subject to change periodically and you will receive notice before this happens.)
- If you wish to terminate your membership for any reason, you must fill out a Cancellation Form (provided by management upon request) **before the 15th of the month prior** the billing dates. If you decide to terminate your membership for any reason, **already processed dues will not be refunded.**
- Memberships are automatically renewed annually, quarterly, or monthly depending on the payment option you choose. Membership is renewed automatically unless a completed cancellation form is received by the 15th of the month prior to the billing dates, which is the 1st day of the month for monthly, quarterly and annual payers (unless specified otherwise).
