LOOKING FORWARD

The Business Development Team is working hard to position A3T for additional opportunities with Unmanned Aircraft Systems (UAS). As you know, demand for UAS technology has grown exponentially, but the FAA faces considerable challenges before these systems can be fully integrated into the National Airspace System (NAS). The FAA just released a market survey request for the New Entrants Division (ANG-C2) which supports the evolution of the NAS by integrating research and development (R&D) to refine NAS operational requirements and influence NAS operational improvements and sustainment. ANG-C2 manages the FAA's UAS and Improved Multiple Runway Operations R&D portfolios. This includes program management responsibility for the execution of relevant R&D to support Aviation Safety and NextGen requirements for UAS integration into the NAS, wake separation standards, closely spaced parallel operations, and ground based augmentation system cost benefit studies. The New Entrants Division (ANG-C2) also conceptualizes, investigates, and executes initiatives and capabilities that support transforming the NAS. This includes separation standards (e.g. wake turbulence). Wake Separation Standards is an area that continues to develop and needs to be investigated, and have appropriate standards, processes and practices defined and subsequently bridged from development to operations.
