- Grant Application for concreting the Small Animal Barn went into McConnell Foundation, working on getting 6 Porta Coolers for Jr. Livestock Animal Barns, one at each end of the barns, we used the Exhibits coolers last year and kept small animals cooler. The Six Rivers Lions Club sent in a grant letter of support and \$500 towards this project. We received grant letters from Trinity County Agriculture Alliance, Hayfork Chamber, and Hayfork Rotary.
- Working on an Agreement with the Grasshopper Bike Event, June 11 13; for all our tent sites, this includes the north dirt parking lot, and any open RV sites for up to 400 campers. They will also use the fairgrounds for entertainment that they are booking, we will rent the facility to the organizer.
- Received a subpoena regarding our Golf Cart Policy, which we do not have, we have a Rule in our Fair Camping Rules. This is for a suit with the Dixon May Fair, where a Vendor hit a Guest with their golf cart. Contacted our Attorney and they said to respond with what we have, which we were able to do via email. Also talked to CFSA and they said all California Fairs received this subpoena, it is probably a good idea for us to create a Policy, so I will work with the Policy Committee on this.
- Currently we have sold \$910 in Money Tree Raffle Tickets and \$530 in Tractor Raffle Tickets.
 - We can sell you a "Book of Tickets" gets everyone to want to buy 10 tickets.
- Hayfork Chamber is redoing the Welcome Sign coming into town it gave us the opportunity to have our sign updated with our Logo, so that has been emailed off to the chamber.
