6. Old Business

The new lease agreement discussion will be tabled until the next meeting because the Fire Company President is not present.

The new Fire Company generator maintenance contract is now in effect. Atlantic Switch & Generator has already performed the first minor PM (preventative maintenance schedule) and the reports have been filed. The next PM (major) and is scheduled for February 2016.

The new application and the process for new fire company members is now in effect. This process includes a new application form. Thomas Bellone Sr. made a motion to accept the new application form and Andrew Bellone Jr seconded the motion. This form is located on the website for download and printed copies will be available.

The background check process is being worked on and will be implemented ASAP.

The Board of Fire Commissioners, District 4 and the Fire Company will be researching a policy and program for zero tolerance for drugs and alcohol. This will also include a process and training of certain personnel for identification of potential "under the influence" and a medical method for determining that a member was actually "under the influence" in the event of an incident.

The Board of Fire Commissioners, District 4 and the Fire Company will be researching a policy and program for medical physical program for all Fire Company members.

The issue of using PO forms vs. vouchers has been resolved. The voucher system will be used for all recurring bills that the BoFC District 4 is responsible for. The Fire Company and the Chief will still need to submit individual PO forms for their purchases.

A new set of By-Laws for the BoFC District 4 is currently being worked on.

7. New Business

The use of Fire Company vehicles being used for members 18 years or older to travel to an approved fire school or course was discussed. It was determined that the BoFC District 4 will no longer allow Fire Company vehicles to be used by individuals to travel to schools. This is due to the need for the apparatus for an emergency call. This policy will not apply when the Fire Company uses the apparatus for a mass training session such as live burn training. Individual members will instead be paid the mileage to travel from the Fire Company to their schools. The members going to school will report to the Fire Company to pick up their PPE and then travel to the school. A mileage payment will be \$0.52 per mile.

7. New Business - continued

The member will be required to submit a travel form with the dates and location of their schools. Once the member passes the course, the member will be reimbursed for the travel costs. Mykola Myronowskyj will obtain actual mileage using Google maps to be used for verification. He will also create the reimbursement form.

Several single purchases were identified by the auditor. Single purchases by the Fire Department are not authorized and the Chief was notified of this information.

Training costs for members that are going to fire school were discussed.

For the members that are solely members of Forest Grove Fire Department, the costs for the school will initially be the responsibility of the member. Once the member passes the course, and provides the required certification documents, the member will be fully reimbursed for the school.

For the members that are joint members of Forest Grove Fire Department and another department, the costs for the school will initially be the responsibility of the member. Once the member passes the course, and provides the required certification documents, the member will be reimbursed half of the cost of the school. The remaining balance will be the responsibility of the member to obtain from the other department.

In the event that the member quits the school prior to completion and receiving their certificate, the costs for the school will be the sole responsibility of the member.
