- Conrad Bellavance joined the meeting to introduce himself to our town. He grew up in Hardwick, VT, and works at Fred's energy. This is his first run as a State office position and is currently working on getting all the signatures he needs to be able to be put on the ballot this coming August. One of his goals is to help get the affordability act passed to lower the State taxes. He also would like to see Vermont be a place where people want to live again.

Patrick Travers-GPI:

- Update on Bridge #10 Rte. 58: Patrick updated the Board that A. L. St.Onge has now signed the contract and is in the mail on its way back to the Town of Lowell for signatures.
