**TOWNSHIP OF BLAIRSTOWN
COUNTY OF WARREN
STATE OF NEW JERSEY**

AN ORDINANCE TO AMEND CHAPTER 184 “VEHICLES AND TRAFFIC”, SECTION 184-28 OF THE CODE OF THE TOWNSHIP OF BLAIRSTOWN ENTITLED “SPEED LIMITS” TO ADD KISHPAUGH ROAD AND MAIN STREET

WHEREAS, Chapter 184 of the Township Code regulates vehicles and traffic in the Township, including speed restrictions on certain roads throughout the Township; and

WHEREAS, pursuant to N.J.S.A. §39:4-98, the Township may establish a speed limit of 25 miles per hour in any residential district; and

WHEREAS, the Township has received requests to establish speed limits on Kishpaugh Road and Main Street in order to promote safer driving conditions on the roadway; and

WHEREAS, the Chief of Police has reviewed the matter and the traffic conditions on Kishpaugh Road and has recommended that the speed limit be established at 25 miles per hour; and

WHEREAS, the Chief of Police has reviewed the matter and the traffic conditions on Main Street and has recommended that the speed limit be established at 15 miles per hour; and

WHEREAS, the Township Committee has reviewed the request and recommendation and determined that it is necessary to amend the Code to establish a 25 miles per hour speed limit along the length of Kishpaugh Road and 15 miles per hour speed limit along the length of Main Street; and

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Blairstown, Warren County, New Jersey, that Chapter 184 “Vehicles and Traffic”, Section 184-28 entitled “Speed limits” of the Code of the Township of Blairstown be amended to read as follows:

SECTION 1. Section 184-28 “Speed limits” shall read as follows:

Belcher Road	25 mph	Entire length
Cedarville Road	35 mph	Entire length
Centerville Road	30 mph	Entire length in Blairstown Township from Township line to County Route 655

Cooke Road	35 mph	Between Hope Township-Blairstown Township corporate line and Mud Pond Road
Cobblewood Road	40 mph	Entire length
East Crisman Road	25 mph	From N.J. Route 94 to the Blairstown Township-Hardwick Township line
Heller Hill Road	35 mph	Entire length
Jacksonburg Road	25 mph	Entire length
Kishpaugh Road	25 mph	Entire length
Main Street	15 mph	Entire length
Maple Lane	30 mph	Entire length
Mohican Road	35 mph	Between Route 94 and Cobblewood Road
Mohican Road	45 mph	Between Cobblewood Road and Gaisler Road
Mount Vernon Road	35 mph	Entire length
Mud Pond Road	30 mph	From Hope Road (County Route 521) to the Blairstown Township/ Frelinghuysen Township line
Shotwell Road	30 mph	From Delaware Road (County Road 655) to Kishpaugh Road
Stillwater		
(a)	35 mph	Between Route 94 and the northerly Road Township line, except as provided in Subsection b below
(b)	25 mph	In the Blairstown Elementary School Zone when traffic is passing through the school zone during recess and/or when the presence of children is clearly visible from the roadway and/or when children are going to or leaving school and/or during opening or closing hours of the school

Name of Street	Speed	Location
Union Brick Road	35 mph	Entire length
Walnut Valley Road	40 mph	Entire length

All other portions of this Chapter remain unchanged.

SECTION 2. All ordinances or parts of ordinances of the Township of Blirstown inconsistent herewith are repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.

SECTION 4. This law shall take effect immediately upon final passage, approval and publication as required by law.
