Happy Valentine's Day!

Husbands, love your wives, just as Christ loved the church and gave himself up for her - Ephesians 5:25



It was Valentine's Day, a long time ago, when Sharon and I were just friends. working in the same church office. While she was at work, I but a heart shaped box of chocolates on the front seat of her parked car with a note attached, "From your secret admirer." She thought it was from Lois, a coworker in her department.

Guys: If you want to communicate your interest in a young woman, this approach has more than a couple of flaws and is not recommended.

Well, somehow, I managed to let Sharon know of my affection more effectively and, although I do not recommend hasty courtships or short engagements, four, months later, we were engaged and in late August, we were married. It was the best decision of my life.

The Bible says (in five different places) that, in marriage, a man and woman become "one flesh." It is not something that happens guickly or obviously. But gradually, over the years, loving couples are blessed with shared affection, common concerns, and a unified purpose. At some point they realize that they have formed a union deeper than anything they could have imagined or achieved when they first came together.

I don't know how this happens. I suspect that it is different for everyone. But I want to give a few suggestions for young (and not so young) lovers who want to experience long and lasting love.


Take your promises seriously - The purpose of marriage is not to celebrate the joy and excitement of new love. It is intended to form a bond between a woman and man that will keep them together through the adversity that is sure to come to every couple. Over the years, I have observed that depth of commitment is the most important factor in achieving a lasting, loving marriage.

Be more concerned with giving than getting - In our self-absorbed culture, it is easy to be caught up in our individual wants and wishes. We are inclined to focus on our own wishes, happiness, and ease. But Godly love is giving love. Christ gave himself for the church. Husbands and wives building marriages will humbly give time, attention, and care to each other. Jesus said, "Whoever tries to keep their life will lose it and whoever loses their life will preserve it." (Luke 17:33) When we give our life to our beloved, we are blessed in ways we could never imagine.

Work together as a team - From the beginning God knew that people are meant for community. Couples help and support each other. The Stephen Covey advice, "Begin with the end in mind," can help to keep wives and husbands striving in the same direction. A line from a prayer in our marriage liturgy suggests what that end might be. "Bring them to old age, together rejoicing in love more fully than they do today." A united effort will make that aspiration a reality.

So, while chocolates may be a good idea for Valentine's Day (especially if you sign your name or present them in person), mutual commitment, selfless love, and shared goals are needed to gain the rich unity of an enduring marriage.

DISASTER BUCKET/ PERSONAL CARE KIT FEBRUARY MISSION

The mission focus for February is the Disaster Bucket/Personal Care Kit project. The Northwest Ohio Association of the Heartland Conference of the United Church of Christ has had this project going for a number of years. The mission donations for this month will provide for the purchase of supplies to put together disaster buckets, which contain cleaning materials to assist with clean-up after a disaster, and personal care kits, which contain products that would be helpful for persons who may need to go to a shelter after a disaster.

In the United States in 2020, there were 1,022 confirmed tornadoes. Those tornadoes in many cases resulted in folks needing to seek shelter due to damage to their homes. Hurricanes in the United States last year caused billions of dollars in damages, and also forced folks to seek shelter. Then, after it is safe to return to their homes, these folks must deal with massive clean-up in order to be able to reside in their homes, if they are salvageable. Many of these disasters also lead to massive flooding in areas not directly hit by the tornadoes or hurricanes.

Think about all of the people who have been affected. They are displaced from their homes, transported to a shelter with nothing but the clothes on their backs. They are devastated emotionally due to the loss of or damage to their homes. Disaster buckets and personal care kits that the Disaster Relief Team provides can be a ray of hope in a time of great despair. Generally, the disaster buckets and personal care kits will be used within our area of the country to meet immediate needs. Keeping the supply stocked means that, when the need arises, the Disaster Relief Team can be there for those in need.

This year, due to the pandemic, we will use monetary donations to buy supplies for the disaster buckets and the personal care kits, rather than asking folks to purchase and bring supplies to the church. With the church building not being as accessible as it would normally be, and the efforts to keep folks socially distanced, this makes it the safest way to support the mission. The Mission and Stewardship Team thanks you for your support of our mission focus.
