

# CALHOUN COUNTY FAIR ASSOCIATION Special Rules for Clothing

- 1. **REGISTRATION** is Sunday October 14, 2018 from 3:00 to 8:00 p.m.
- 2. Entries are limited to one item per category per exhibitor. If a division category has subcategories, only one entry in each sub-category will be allowed per exhibitor.
- 3. Adult entries will be judged based upon the following separation:

a. Adult: 19 - 64 years old

b. Senior Citizens: 65+ years old

4. **Youth entries** will be judged based upon the following separation:

a. Sub-Junior: 4 years old – 8 years old

b. Juniors: 9 years old – 13 years old

c. Seniors: 14 years old – 18 years old

- 5. Day Care and Preschool ages Ribbons only
- 6. Entries will be judged on the basis of accurate cutting and quality of construction techniques.
- 7. Awards a blue, red, or white ribbon will be awarded to each entry based upon merit. Grand & Reserve Champion rosettes awarded within each Division by Age Category based upon merit.
- 8. All entries must be machine sewn or hand sewn by exhibitor.
- 9. Exhibitor must provide hangers for all entries that can be hung.
- 10. Garments must be clean and neatly pressed. Entries will be judged on the basis of accurate cutting and quality of construction techniques. Garments showing signs of wear will not be accepted.
- 11. Exhibitor may provide a clear plastic bag to cover garment after judging.
