

Lin Jensen

Lin bought her first Boxer in 1977. She was a bitch out of the Herndon Lines. She was a "runner" so Lin started working her in obedience. She received her CD title within a year. Lin trained 7 dogs that earned their CD titles over the years.

Lin had her first litter in 1982 and kept 2 puppies. They went on to be American, Canadian and Mexican champions as well as earning their CD titles. Lin went on to breed 17 champions.

Lin enjoyed stewarding and was an AKC judge. She served on the Board of Directors for the Boxer Club of Arizona and was President of Superstition Kennel Club.

Lin also served in the Army when she was a young lady. She really enjoyed the shooting range!

Lin had a son and daughter as well as 2 grandsons and several great-grandchildren.

Lin had a generous heart and was friends with everyone. We will miss her warm smile around the show ring!

In Memoriam



Dixie McCauley

Dixie moved to Arizona in the late 40's to teach dance at the Arthur Murray dance studio. Dixie answered an ad in the newspaper and became one of the first group of women officers hired by the Phoenix police department. She worked vice and really enjoyed arresting the "Johns"!

She left the Phoenix police to be head of security for Goldwater's and later, Diamond's department stores. She became an expert in spotting shoplifters. There weren't any cameras back in those days, so the detectives had to spend a lot of time in the store's ceiling crawl spaces. This left Dixie with a major case of claustrophobia!

Dixie's greatest passion was for her dogs. Dixie imported the first Vizslas from Hungary into Arizona in the 1950's. She was a founding member of the Boxer Club of Arizona also in the 1950's. She was an all-breed handler and judge for many years. Under the kennel name Candlewood, she bred many champion Boxers & Italian Greyhounds. CH Candlewood's Weekend Warrior, "Rio" was her top winning Boxer and her pride and joy.

Her generosity, huge smile and spitfire personality will live on through our memories.

Breed Judge: Clay Coady

Mr. Coady competed in his first dog show at the age of 12, with his first pure bred dog, a Samoyed named Snow. He didn't win, but it ignited a passion for the sport that still burns to this day. His career in dogs was blessed by the good fortune to work with the very best of people and dogs. In his teens he worked for legends Ben Brown and, later, Larry Downey.

In his 20s, he set out on a successful professional handling career with his then-wife Bergit. Before it was over, he would handle some of the top-winning dogs of their time for some wonderful clients, finishing and specializing dogs in every group.

Mr. Coady retired from handling in 1999 to focus on his business interests including boarding kennels, veterinary clinics and pet supply businesses in the Phoenix, AZ area. He has been judging since 2001, and presently is approved to judge breeds in every group as well as the Sporting, Working and Terrier Groups, and Best in Show.



Breed Judge: Lee Herr

Lee was an AKC Rep in the southwest for over 10 years. He has been an approved judge for 20 years. Lee has been active in the New Castle KC, where he served as Show Chairman and President. He has also served as Cluster Coordinator for their Memorial Weekend Classics.

Lee grew up in the family farming business and has been involved with bovine and equine husbandry his whole life. His interest in dogs came as a natural evolution.

His varied professional background includes every aspect of food processing from research and development to marketing and spokesperson for a highly successful corporation.

Conformation Judge: Robert Robinson

I began my judging career in 1994 and am currently approved by the American Kennel Club to judge the Working, Sporting, Hound, and Herding Groups, Junior Showmanship, and Best in Show. In addition, I judge for the United Kennel Club, the American Rare Breeds Association, and the Australian Shepherd Club of America.

I am an AKC Breeder of Merit having bred approximately fifty breederowner handled champions of record including National Specialty winners, and hunt test/field trial qualifiers. I have attended weight pull competitions, lure coursing, herding trials, coonhound night hunts, obedience/agility trials, as well as hunt tests/field trials. It has been my privilege to contribute to the dog fancy through participation in the Irish Setter Club of America where I served as President and National Specialty Show Chair.

I currently am an active member of the Working Dog Club of Arizona serving on its Board of Directors and as Treasurer of the club. I am a member of the Dog Judges of America, and the American Dog Judges Association. I am a founding member and President of the Sporting Dog Association of Arizona, and a founding member of the Arizona Dog Judges Education, Inc. I have served six terms as the President of the Irish Setter Club of Arizona, one term as a director/member of the Irish Setter Club of Greater Tucson, and as both President and Treasurer of Sahuaro State Kennel Club.



Conformation Judge: Sharon Steckler

I have been celebrating Boxers for over forty and am excited to see the variety of performance, herding, nose work, barn hunts, lure coursing (even dock diving!), and conformation events in which boxers are not only participating, but winning! Boxers in the roles of therapy dogs, search, rescue, and assistance animals are true stars.

It has been such fun to breed and finish 13 champions, including an ABC dam of merit. I am a life member of The American Boxer Club (ABC) and am privileged to serve ABC as treasurer and director. At the Judge's discretion, Award(s) of Merit will be awarded to Boxers who are in serious competition for Best of Breed awards. It shall be entirely the judge's decision to award all, some, or none. Awards of Merit shall be awarded to dogs and bitches other than the Best of Breed and Best Opposite Sex winners. The AOM criteria is as follows:

5 Champions – 1 AOM 15 Champions – 3 AOM 10 Champions – 2 AOM 20 Champions – 4 AOM

Dogs Left In Parked Cars

In the event that it becomes necessary to rescue an animal from a parked car on the show grounds or parking areas immediately surrounding the show grounds, the Boxer Club of AZ, Orange Coast Boxer Club, or the Leaps and Bounds Agility Center will not be held liable for any damages incurred as a result of rescuing the animal.
