Public Works Report: The public works report was circulated and discussed by council. Council was concerned about the repetition in some of the report as the decisions regarding the two weeks' notice by mail was previously made at the last meeting. Councillor Berkholtz questioned what the three phases were for the pump house this year. Council will be hiring a contractor to tackle the problem of muskrat control at the lagoon. The culvert repair that crosses Main Street for the north corner to the ditch kitty corner from the Tempo Station is not in the budget to repair this year. Council will consider having a quote to replace the culvert by directional drilling in next year's budget. Council would like administration to contact Wayne Nyback to be in town on the day that street sweeping takes place so he can enforce the removal of cars from the street. Tree planting is to begin this year. Council would like to consider different trees to the three recommended as those recommended could be poisonous to dogs. Council would also like the spruce tree at the post office removed this year as they feel it is not safe. Public works asked that approval be made in the budget for Crushed Gravel to be delivered; and a chainsaw for trimming the trees within town. These will be purchased this year. The other requests for a flat deck trailer and the pressure washer is not to purchased this year due to budget restraints.

Until that time, council sees no reason for Public Works to maintain the area as park land.

  Administration is to contact Megan Patten to find out if she is willing to take
  the responsibility of the Director of Emergency Management for the Village.
- Municipal Affairs Assessment Audit: The final report was presented to Council.

- Alberta Municipalities 3<sup>rd</sup> Party Property Damage Claim has been finalized and all costs associated (\$2,500.00) has been paid out.
- Taxervice Charges on Roll # 10500: This matter was discussed in detail by Council and Administration. Council has decided that these charges must be added to this year's tax assessment and notice despite Administrations initial decision.
