Scott: We are in need of general maintenance work and lawn service maintenance within the town limits.

Sarah: The historical society is very appreciative.

Doc: Unrestricted Funds are \$3,290,892.38 and Restricted Funds are \$981,169.00 for a Grand Total Fund Balance of \$4,272,061.38.

Randy: Is everything going to suit you Scott?

Scott: Everything is looking good and in order.
