A. <u>Resolution 23-1019; Splash Pad Research and Grants</u>

A RESOLUTION APPROVING RESEARCH AND GRANT APPLICATIONS FOR SPLASH PAD CONSTRUCTION AND DECLARING IT AN EMERGENCY

Mr. Greg Iiams moved to accept Resolution 23-1019 on the second reading. Mr. Dave Wallace seconded the motion.

Ms. Joan Hinterschied gave some information to council on the two different types of splash pads. First, a recyclable water method requires a storage tank underground and a certified water operator. The other method is a pump and dump. The water is not recycled using this method. Ms. Hinterschied also gave information on local splash pads who use the pump and dump method. The Village of West Liberty dumps their city water from the splash pad into a local creek. They are able to use this process due to low levels of chlorination.

CITIZEN COMMENTS:

A. Ms. Krista Oldiges

Ms. Oldiges from the Logan County Board of Developmental Disabilities (LCBDD), voiced her support for the splash pad. The LCBDD has offered a donation of \$10,000.00 towards the project and to help write any grants. She stated that their board often rents the splash pad in West Liberty, Ohio. Some families travel from Indian Lake to their events.

B. Ms. Dianne Gauder

Ms. Gauder advised council that a few parents who are interested in the splash pad, have stopped by the municipal building for information. These parents are not comfortable letting their children swim in the lake due to the chemicals that have been used for the over growth of weeds. Ms. Gauder advised them to attend the council meeting.

C. <u>Mary Jo Forgione</u>

Ms. Forgione asked what was planted in the white poles behind Low Bobs. Mayor Reames advised it is part of a flood plain conservation program to help foster the growth of that property.

D. Ms. Sharon DeVault

Christmas tree lighting was a huge success. Ms. DeVault also asked why in chapter 183.04, is the Logan County Visitors Bureau receiving the 3% bed tax. Why is it not going to the Indian Lake Visitors Bureau?

There was some discussion between council and the Mayor in regards to reaching out to the solicitor to have this changed.

E. <u>Chief Joe Freyhof</u>

Chief gave an oral report on his department. The Progressive Christmas dinner will be held this Wednesday at 5:30 p.m. Protection from the department was provided at the annual Christmas tree lighting. A crash report and written reprimand has been completed for the crash involving Officer Styles. The insurance company is going to provide a salvage value in the amount of \$15,426.00. Chief discussed the purchase of a Dodge Cruiser that was planned for 2024. This vehicle will not be available until late summer/late fall. The department will be attending the Shop with a Cop event that is put on by the Fraternal Order of Police on December 16, 2023.

EXECUTIVE SESSION:

OLD BUSINESS:

A. Medical Insurance, 2024- Corrected Information

Ms. Taylor Thompson reported that the medical plan previously selected for 2024 is significantly higher that originally quoted. Waypoint Benefit Solutions gave information for medical rates based on the 2023 employee census, which is incorrect. Waypoint was provided a 2024 census from employees in early November. Council was provided the correct rates for each medical option for 2024. There was a brief discussion regarding the differences in plans.

Council was provided an additional quote from Security Professional Unlimited to provide a keyless entry system. There was discussion about the changes that would have to be made. It was approved at the previous meeting to use Habitec Security for the keyless entry and it was agreed to remain with that decision.

C. Park Restroom

Mr. Wallace asked if the restroom is winterized. Mayor advised she would get with Mr. Tim Reese in regards to this or Mr. Wallace may.

NEW BUSINESS:

A. Pavement Analysis

Mayor provided council with a quote for a pavement analysis that needs to be budgeted for in 2024.

B. LED Sign

A LED sign was budgeted in 2022. The Mayor has reached out for quotes from different companies. Due to inflation, the cost has risen from quotes previously received. No action has been taken on this appropriation in quite some time. There was some discussion regarding increasing this amount the procedure of it.

Ms. Joan Maxwell made a motion to adjourn the meeting. Ms. Shannon Stinemetz seconded the motion.
