


Executive Board Minutes

I. FLEX Spending

If you wish to participate, you need to submit the forms by November 13th. Just as a reminder, for the 2021 year, you may incur expenses for an additional $2\frac{1}{2}$ months and have 90 days to submit your claims. Please keep this in mind as you complete the application as this is a "use it or lose it" plan. Please reference Dr. Natali's email from 10/22/20 for more information.

J. Study Money Dates

Those who applied were approved for Fall Study Money on the October 13th Board of Education agenda. There was about \$6362 not used in the fall that will carry over to the winter. There are two more opportunities to participate in the Study Program: December 11, 2020, Summer – May 14, 2021. Members with permanent or professional certification may apply for up to \$1,750 in study money per semester. The application is available online at Request for Participation in Study Program — Group A.

K. Annual Turn-In of Sick Days

If you have accumulated at least 75 sick days and wish to exercise your option of selling back unused sick days earned this year (up to 12 or 14 if you worked at Summer School) you must submit a "Request for Payment in Exchange for Accumulated Unused Sick Days" form to the HR Department. The teacher must not have been absent more than 6 days during the school year for which he/she shall claim eligibility for this payment.

G. Teacher Center—John Marr

1. We are happy to report that the state office of the budget has begun repaying districts for the remaining grant from the 2019-2020 school year. The state is currently paying these reimbursement of 80% of the claim. There had been no notification when the initial 25% of funding owed to Teacher Centers this year will be released. Many centers across the state fear funding will be pulled and they will be forced to close. With this in mind I am happy to remind you that the Long Beach Teacher Center anticipated this scenario a number of years ago and became an incorporated 503c not-for-profit. As such we have set aside enough funding to run the center without funding if that were to happen. As always, the \$40 class fee (\$42 if you pay digitally) covers as much of the instructor course as possible

while the balance is paid out of our not-for-profit. This will continue as we hope the state will release funds by December.

III. Executive Vice President's Report—Karen Bloom

A. As we continue to learn and adjust to our new way of teaching, we ask that all parties involved be patient and support us as much as possible. This is one of the most difficult things that we have ever been asked to do.

B. APPR

- 1. You should have received something stating who your evaluators will be for this school year. If you did not, please contact your immediate supervisor and let them know.
- **2.** We have spoken to Dr. Romanelli regarding APPR and observations. He has assured us that administrators are here to support us, and that they will be mindful of our current situation.
- **3.** Please take an active role in the observation process. Keep in mind that the Danielson framework that we use is based on best practice and observable measures. You should not see opinions from your evaluation team. Be sure to address issues in your post observation conferences.
- **4.** Our APPR handbook is on our website. You can find all timelines, conversion charts and percentages here.
- **5.** Feel free to contact me if you have specific concerns regarding APPR.

C. Health & Safety Committee

- 1. We were able to look at all the results from the new testing of each individual space in the High School. Overall, most areas are functioning at or above the recommended CFM's per person (10). There were a few spaces that the vents had to be adjusted to allow more fresh air in, but they have already been addressed. These reports will now be used to help to determine suggested occupancy of each room. The potential issue is when we return to full capacity. Brendan Scully and Chris Genduso are now using these reports to adjust the units in each space to accommodate more people in each room. These will be shared with building administrators so that the limits are not exceeded. We hope that these will also be used when determining when and if more students can return to full time.
- **2.** Thank you to Mr. DeVito who has been willing to get these reports done on a regular basis. These reports are above and beyond what is required. He has already asked JC Broderick to come to retest to make sure that our adjustments are sufficient. We will continue to monitor the reports and make sure that each space is functioning properly and that the amount of fresh air coming in is at or above the suggested standard.
- **3.** You may also have noticed much colder temperatures in some areas. Remember, units must be running 24 hours a day, 7 days a week! So, they used to shut down at night or on weekends. That can not happen now, so areas are remaining much colder. Please speak to your head custodian as they may be able to adjust the temp a bit, but please be patient as we all work through these issues. In most cases, we are choosing more fresh air, which may mean colder temps.
- **4.** According to Mr. DeVito, all cleaning and sanitizing logs will be kept on file by the head custodian. Each cleaner will be initialing daily that both cleaning and sanitizing has occurred in all spaces that they are responsible for. If you need information about a specific room, you can reach out to Chris Genduso and cc Mr. Myers with your request.
- **5.** We are hoping to hear a date for our first Health & Safety meeting sometime in the near future. In addition, we would love to get an update on the traffic project!
