
How does Utah achieve permanency?


Our goal is to prevent abuse and help families stay together when it's safe to do so.

Achieving permanency judicial process overview

Once a child has been placed in DCFS care all 5 parties work together to achieve a permanent home. However, the ultimate decision lies with the judge.



*Parents are entitled to parental defense.

Moving to permanency

Utah Legislation understands the importance of children moving to permanency and supports our practice through statute.


The language in Utah State Code 80-2a-201 promotes:


- Reunification
- Concurrent permanency planning
- Prioritizing kin



Reasons children left foster care during FY 2023

74.2% of children were reunited with their family or adopted through kinship

Permanency goals and concurrent planning include:

- Reunification
- Adoption
- Guardianship (relative)
- Guardianship (non-relative)
- Individualized permanency




Partnership with the courts

DCFS has a close partnership with the juvenile courts and participates in collaborative efforts to make sure missions align and great work continues.

Emphasis on kinship



Emphasis on kinship

Research shows that placing an emphasis on kin from the start leads to improved outcomes once a family is involved with the child welfare system.

- Family action meetings (FAM)
- Parent-child substance use treatment programs



Ongoing efforts for complex youth

Despite current efforts to move youth out of the foster care system by 12 months, DCFS does experience trouble at times with finding permanency for youth with complex needs.
