Presidents Report:

-A motion was made by DT and seconded by SR to ratify the lawsuit filed and settled against a homeowner who was not following the Association's Covenants with regard to minimum standards in new construction. Vote was unanimous.

-There has been vandalism of one of the bladders used for the lake restoration project. Officer Durham of the SGPD is working on the case and the Association's insurance company is sending an adjustor to evaluate the situation with regard to reimbursement. SR will investigate the possibility of installing temporary fencing around the bladders to prevent further loss.

-Our attorney, Beth Schaffer has submitted an estimate for the legal work involved in updating our Covenants of approximately \$5000. A decision to accept this was not made at this time
