All extrication equipment has been transferred to the 13 Fire Departments in the County.

Annual disbursement of \$25,000 to the Fire Chiefs from the County to help replace and maintain extrication or other equipment as needed and deemed by the Departments.

Road ordinance from the County is for the 6 Townships without zoning. County

Addressing Ordinance supersedes the Township Ordinance.
