TODAY'S MEETING

The June 13, 2018, KPCR meeting was held at the KNEA location. BTW we voted to give the new venue a try for a year. The next meeting will be July 11, 2018 (the second Wednesday as usual).

During this morning's discussions it was suggested that the following Items be stated:

- 1. While KCPR's goal has always been to see a COLA implemented we also need to point out that we are deeply concerned about the funding of Actuarial funding of KPERS. This concern amplifies the concern for the presently working as well. The Pension Plan for the Kansas public employee (KPERS) is an "all for one, one for all" program. Any improvement in the above listed items in the long run benefits all in the KPERS/KP&F/Judges retirement system.
- 2. To better inform you, we have placed on the KCPR Website (<u>www.ksretirees.org</u>), under the heading of "News Flash Corner," three items of interest.
 - a. Complete Talking Points which include information on KPERS in general.
 - b. A "White Paper" which includes KPERS facts, as well as some observations and research on Pensions in General.
 - c. Finally an article relating to Truths and Myths around KPERS. This describes some of the positive outcomes we have been able to impact over the years regarding KPERS.
 - d. Additionally, contained on the website is the 2018 Report to the Legislature. On pages 10-12 are the annual KPERS benefits received by county. This is great information we find that the candidates are always interested in.

These articles will also be helpful in talking to the candidates in the upcoming elections.

The agenda was discussed this morning included the following:

- A. Possibility of a Special Legislative Session over School Finance.
- B. Discussion of the list of Kansas House Candidates for the fall elections.
- C. Discussion around the possibilities of a Letter to the Editor Campaign regarding the upcoming elections and session.
- D. Planning for KCPR visits to KPERS Board Meetings for "public comment"!
- 1. The only reason for a 'special session' of the legislature this year will be if the Kansas Supreme Court indicates that more revenue needs to be funneled into Kansas educational funding. This subject is at this point unresolved as the KSC has not yet ruled on the school funding bill.
- 2. While we are not in a position to make recommendations, we can as indicated in #2 above provide you information that will help you make this determination.
- 3. As the fall elections approach, we know there will be negative comments regarding public employees and public pensions. We are working on plans to combat these attacks.
- 4. KCPR will periodically attend KPERS Board Meetings and comment on COLA and funding issues during the 'Public Comment' portion of the KPERS Board Agenda.

a. Further discussion of candidate information.

- b. Prepare for our semi-annual fall fundraiser.
- c. Begin working on the 2019 Report to the Legislature.
