Guilty as charged. Dr. Dan Stock. 5777 West Seminar North, McCordsville, Indiana. To address your comment? Gee, it is hard to believe we are 18 months into this and still having a problem. And I would suggest the reason we still have a problem is because we are doing things that are not useful.

And we are getting our sources of information from the Indiana State Board of Health and the CDC, who actually do not bother to read Science before they do this. I am actually a functional Family Medicine Physician. That means, I am specially trained in immunology and Inflammation Regulation.

And everything being recommended by the CDC and the State Board of Health is actually contrary to all the Rules of Science. So, things you should know about Corona Virus and all other Respiratory Viruses. They are spread by Aerosol Particles, which are small enough to go through every Mask.
