The Proposed Simple Bill

- **“ An Act making drugs listed in Schedule 1 of the federal Controlled Substances Act illegal in Montana;**
- **Section 1. Compliance with Schedule 1 of the federal Controlled Substance Act. A person may not legally possess, receive, transfer, manufacture, cultivate, traffic, transport, or use in Montana a substance that is listed in Schedule 1 of the CSA, 21 U.S. C. 812.**

2015 “No to Illegal Drugs” Bill

Safe Montana Vote YES!

Drugs are Federally Regulated: No State Involvement. Repeal Montana Marijuana Act.

Clarity: No ambiguity between Federal, State, and City Law.

No legal recreational use of any Schedule 1 Drugs

2011 SB423 MM “Side Boards” no longer needed. Law still held up in court as unconstitutional.

Federal FDA medical marijuana has been approved in all 50 states with more products coming. Marinol and Cesamet FDA approved and Sativex FDA FastTrack coming in 2015.

No need for Montana to be involved in unregulated medical marijuana...lot's of exposure...untested!

2015 “No to Illegal Drugs” Bill

SafeMontana Yes!

- Medicine is managed at the national level(FDA).
- Repeal Montana Medical Marijuana State Green Cards (broken...unregulated system)
- 2011 SB 423 Essman Bill held up in Court as unconstitutional.
- This bill fixes the Schedule 1 problem and gives clarity to law officers, legal system, school system and health care providers.
- FDA has approved MM as a Schedule 2, 3, or 4 drug available to all Americans in 50 States
- FDA Approved Marinol (THC) and Cesamet pill available now by all Doctors and Pharmacies.
- New MM Drug from Cannabis “Sativex” (50%THC-50%CBD) mouthwash spray (on FDA Fast track for release in 2015)
- Pharmaceutical Company produces it to FDA medicine standards
- Doctor verifies symptom, writes prescription and monitors patient for success.
- Pharmacist...exact amount prescribed

UnSafeMontana NO

- Medical Marijuana grown anywhere and by anyone who can get an unregulated and unmonitored green card. (Again on Butte street corners)
- MM ends up in our schools. MM hurts our kids and families and MT HS drop out ratios.
- “Very Limited” medical supervision (Most MT medical providers and hospitals will not touch Federally Illegal Marijuana.)
- No regulation on amount, quality, quantity, specific strain of MM.
- Legalization of Marijuana supporters want no supervision of the MM process...they want free access to this addicted illegal drug.
