2019 THROUGH FEBRUARY 28, 2019

Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as follows:

1. On August 18, 2016, this Court entered its *Order Appointing Receiver*, which appointed Peter S. Davis as Receiver of DenSco Investment Corporation ("Receivership Order").

2. Pursuant to *Order Re: Petition No. 1*, the Court approved the Receiver's compensation at the rate of \$250.00 per hour together with all reasonable costs and expenses

1 incurred relating to these services as Receiver. These services are billed by and paid to the  
2 Receiver's firm, Simon Consulting, LLC.

3         3. Pursuant to this Court's *Order Re: Petition No. 1*, the Receiver has engaged the  
4 services of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the  
5 Receiver has agreed to pay the law firm compensation at agreed hourly rates for the services  
6 of the firm together with all reasonable costs and expenses incurred on behalf of the Receiver.

7         4. Pursuant to the Court's *Order Re: Petition No. 2*, the Receiver is authorized to  
8 file this fee petition without including as exhibits the itemization of services rendered to, and  
9 costs incurred or expended on behalf of, the Receivership, provided that the fee petition  
10 includes a statement that anyone desiring additional information concerning the services and  
11 costs to be paid under the fee petition may obtain redacted information from the Receiver by  
12 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a  
13 written request specifying the additional information requested at least three (3) days prior to  
14 the date set for any hearing on the fee petition. The Court's *Order Re: Petition No. 2* further  
15 provides that upon request of the Court, the Receiver shall make available for in camera  
16 review by the Court the itemized statements and supporting documentation for the services  
17 and costs to be paid under the fee petition.

18         5. The Receiver has submitted an itemized statement for services rendered to this  
19 Receivership by the Receiver and his firm, Simon Consulting, LLC, and for reimbursable  
20 costs incurred or paid during the period February 1, 2019 through February 28, 2019. The  
21

1 total amount requested for payment by the Receiver is \$6,017.00. The Receiver believes that  
2 this amount is reasonable and should be paid from the Receivership Assets.

3 6. The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized  
4 statement for services rendered to this Receivership and for reimbursable costs incurred or  
5 paid during the period from February 1, 2019 through February 28, 2019. The total amount  
6 requested for payment by the law firm of Guttilla Murphy Anderson, P.C. is \$15,779.50. The  
7 Receiver believes that this amount is reasonable and should be paid from the Receivership  
8 Assets and has therefore approved this statement for payment.

9 WHEREFORE, the Receiver respectfully requests that the Court enter an order  
10 authorizing the Receiver to pay from Receivership Assets:

11 1. The amount of \$6,017.00 to Simon Consulting, LLC, for services rendered to  
12 the Receivership and costs incurred during the period from February 1, 2019 through  
13 February 28, 2019;

14 2. The amount of \$15,779.50 to Guttilla Murphy Anderson, P.C., for services  
15 rendered to the Receivership and costs incurred or paid during the period February 1, 2019  
16 through February 28, 2019; and
