- Surveillance camera documentation/responsibility Discussion Scherrie Whitten questioned Deb Warren in reference to the viewing of cameras off Cedar Hills School campus. The camera system is not installed to view off campus. Ellen Kelley stated that cameras are installed in the classrooms and her concerns were with micromanaging the staff. She also stated that the staff needed the freedom to perform their jobs. Deb Warren informed Mrs. Kelley that there are not any cameras installed in the classrooms. A new surveillance system was installed recently and it consisted of 14 cameras that were for the security and safety of the staff and students.
- 9. Inventory/Audit clarification of information Discussion Scherrie Whitten wanted to clarify prior information in reference to the food service cost per meal. She stated that it had been implied that the cost per meal for the 2016-17 school year had been the cause for Hackberry E.S.D. #3 to be chosen for the performance audit. She had contacted John Ward and he informed her that it was not, Joni Bullock, commented that during the initial interview the cost per meal was discussed because it was a red flag due to it being almost \$13.00 per meal. Ms. Whitten concluded that the former business manager and herself had already answered questions and resolved the issue.
