- Congress and Department of Defense (DoD) exercise close scrutiny over patronage to ensure continued effectiveness
- DoD and Air Force policy on community partnership opportunities varies based on category of MWR program

#### **DoD Policy**

DoD Instruction (DoDI) 1015.10 authorizes DoD Components to "establish agreements with local governments for use of similar Category A and B MWR programs when it is in the best interest of the Department of Defense and when the provisions of such agreements are otherwise in compliance with applicable law and regulation."

#### **AF Policy**

<u>Air Force Instruction (AFI) 34-101 3.1.3.</u> allows establishment of community agreements with local governments so that MWR patrons <u>may use community facilities similar to Category A and B</u> <u>MWR activities that may be available in the local community</u> when it is in the best interest of the Air Force and when the provisions of such agreements are otherwise in compliance with applicable laws and regulations

- Category A and B: MWR agreements must be approved by the Secretary of the Air Force
- <u>Category C</u>: When existing Category C activities have capacity excess to authorized patron requirements, Air Force Services (AF/A1S) may (and often does) grant waivers for local community use on a case-by-case basis

#### **Category C Waiver**

"General Public Use on a Reoccurring Self-Directed Basis"

#### Waiver process is initiated at the installation

The installation commander determines that adequate facilities are available and are currently under-utilized by higher priority users

- Allowing individuals to use specified Category C facility (or facilities) is beneficial to both the military members and civilians in the community
- No conflict exists with Federal, State, or local laws (including Status-of-Forces Agreements)
- Written agreements are obtained from local businesses of like nature, local government officials including the Chamber of Commerce, or other appropriate community leaders indicating they have no objection to expanded use of these programs

Category C Waiver Approval Authority is AF/A1S



## Category C Waiver Cont.

"General Public Use on a Reoccurring Self-Directed Basis"

- Authorization is limited to attendance and purchase of food/beverages and convenience merchandise incidental to participation (such as golf tees and balls)
- The members authorized are designated by letter maintained on file by the Force Support Squadron (FSS) Commander/Director
- Installation commander request for a Category C waiver must contain the information required above and be endorsed by the respective Major Commands and AF Services Activity (AFSVA) Commander
- AFSVA forwards waiver package to AF/A1S for approval

**EXAMPLE:** Civilian Access to MWR Golf Courses

Category C Waiver Approval Authority is AF/A1S



## Special Circumstances that Allow non-DoD access to MWR

- Local leaders program (e.g., Honorary Commanders)
- Force Support Squadron (FSS) MWR Events As authorized by the installation commander
- Invited guests of eligible MWR patrons

Local leaders (Honorary Commanders) as designated by the installation commander

- Category C activities only
- Installation commander re-certifies individuals annually by letter
- Re-certification documentation is maintained by FSS



## Special Circumstances that Allow non-DoD access to MWR

Members of the general public can attend infrequent FSS-sponsored MWR events as authorized by the installation commander

#### Category A, B and C activities

- Rules governing local procedures on the number of guests and the frequency of use at specific facilities will be put into an installation policy letter or installation regulation
- Allowing these individuals to use these facilities is beneficial to both the military members and civilians in the community
- No conflict exists with Federal, State, or local laws (including Statusof-Forces Agreements)

*Examples: air shows, open houses, MWR bowling leagues with a definite beginning and end date, community appreciation event, etc.* 



# Special Circumstances that Allow non-DoD access to MWR

#### **Invited Guests**

- Category A, B and C activities
- Those otherwise not eligible to use FSS MWR programs, when specifically invited and accompanied by an authorized person
- Installation commander approves local rules governing the number of guests and the frequency of use at specific facilities
- Rules governing local procedures on the number of guests and the frequency of use at specific facilities will be put into an installation policy letter or installation regulation
- Allowing these individuals to use these facilities is beneficial to both the military members and civilians in the community
- No conflict exists with Federal, State, or local laws

#### **Authorities**

- Leverage new and existing authorities to identify potential partnership initiatives
- 10 USC 2679 enables intergovernmental support agreements with State and local communities
- Lay out the initiative objectives first, <u>then</u> identify the tools to make it happen
