

Counsel and unrepresented parties are directed to appear to set the order of cases for trial or to show cause, if any, why their case should not be dismissed for failure to comply with mediation order, failure to obtain service, or failure to prosecute. **Failure to appear may result in automatic dismissal without prejudice.** Unless continued by the Court for good cause shown, all noticed cases not disposed of at or before the March 24, 2015, calendar call will be placed on the civil trial calendar for April 28, 2015, trial week. **ANY PRE-TRIAL MOTIONS AND PRETRIAL ORDERS ARE DUE IN JUDGE SIZEMORE'S OFFICE BY MONDAY, APRIL 6, 2015.** All motions and pretrial conferences shall be heard on April 8, 2015, at 10:00 a.m. unless scheduled prior thereto.

ANY WRITTEN ANNOUNCEMENTS RECEIVED AFTER MARCH 20, 2015, WILL NOT BE ACCEPTED. NO EXCEPTIONS WILL BE MADE. If announcement is not received by March 20, 2015, your attendance is required; otherwise, your case will be dismissed for lack of prosecution.
