- e) Mark Waszkiewicz-property on Davis Road next to him is a junk yard. Forty junk vehicles, a bus & semi-trailers on property. Supervisor Boulier stated he is trying to get help from Egle regarding this situation.
- f) Douglas Kubuck-neighboring parcel has a 40-yard dumpster filled with trash. There are trash bags sitting along both sides of the dumpster as well.
