



Personal Responsibility and Liability Waiver

I, (print full name) _____ by signing this **Personal Responsibility, Liability Waiver and Hold Harmless Agreement**, am agreeing to the following requirements, terms, and conditions regarding use of the Good Guys Gun Range (GGGR) located at 953 S State St, Orem UT. This release shall remain in full force and effect so long as I am a member or a user of GGGR facilities or a guest on its property with no expiration for time or other reasons.

- **I understand the risks and hazards involved**, and I recognize serious and potentially life threatening injuries or death can occur while shooting a firearm or participating with others, either in a GGGR sponsored program, on my own at the range, or by simply being at the range while others are present.
- **I understand that a safety range officer (SRO) is not always present** and I accept the risks and responsibility of shooting at a range that does not have a full time safety range officer on the range at all times.
- I swear and/or affirm that **I am at least 18 years of age**, am of good character and moral standing and **am legally entitled to possess and/or purchase a firearm**. I have no criminal convictions, pending criminal charges, indictments or suffer from any form of mental illness that would prohibit me from legally and safely possessing and using a firearm, or would be detrimental or dangerous to me or others while utilizing the facilities of GGGR.
- I agree that I will **never be careless and/or negligent with my firearm and accept all responsibility for any damage or harm caused by my negligent behavior**. I will abide by and obey all rules pertaining to use of the shooting range and will abide by the commands of the Range Safety Officer when present or when being monitored by the closed circuit cameras while utilizing the facility.
- **I also swear and/or affirm that I and/or my survivors, dependents or heirs agree to hold harmless and indemnify** any employee, assistant, proprietor, owner, co-owner, manager, associate or possessor of the land or building and/or facilities of GGGR for any harm, injury, death or property damage sustained or endured while utilizing the GGGR facilities occurred as a result of, but not limited to, my and/or my guest's negligent or unsafe actions, personal equipment, any act of nature, or any unforeseeable event, chain of events or incident. I attest that any weapons, ammunition & other personal equipment provided by me or my guest(s) for use in the gun range are legal to possess, safe & reliable.
- I hereby **consent to receive medical treatment**, which may be deemed advisable in the event of injury, accident and/or illness during the activities at the shooting range.
- I agree and understand that **if I violate any GGGR rules, regulations, or guidelines** that my privilege to use the range may be temporarily suspended or permanently revoked, and I also agree that if I have provided any false statements or information, **my privileges will be immediately revoked** with the complete and total forfeiture of any dues or membership fees paid to GGGR.

Range Rules

Please read and understand the Range Rules and Regulations before you proceed to the range. Please ask any staff or the Range Officers for clarification if you have any questions.

1. **Always keep your firearm pointed in a safe direction down range.**
2. **No loaded guns are allowed outside of the booth area.**
3. **Only load your firearm at the shooting stall table.** Keep actions open when not shooting.
4. **Always keep your finger OFF the trigger until you are ready to fire.**
5. **Always keep your firearm unloaded until ready to use.**
6. Do not exchange firearms with another lane. Switch shooters, not guns. **Do not hand a loaded gun to another person.** Place the gun on the table and have the new shooter pick it up.
7. Handgun shooters under 21 years of age and long gun shooters under 18 years of age must have parental approval and be accompanied by a parent or legal guardian at all times.
8. No inexperienced shooters are allowed on the ranges without prior instruction, coaching, and approval of the Range Officer or other authorized person.
9. No children under 9 allowed on range (unless approved by an RSO) and must not be left unattended.
10. Range officers are authorized to remove any shooter whose behavior is detrimental to the safe operations of the range. Commands issued by any RSO must be followed immediately.
11. No handgun drawing from a holster is allowed without the prior approval of the Range Officer.
12. No pistol rapid fire shooting is allowed.
13. If you have a malfunction or a jam that you cannot clear, lay the firearm on the bench while keeping the muzzle pointed downrange, and ask the Range Officer for assistance. NEVER remove a jammed or malfunctioning firearm from the range without prior approval from the Range Officer.
14. No more than two shooters allowed on a lane except in the VIP lane.
15. **No steel jacket or steel core** ammunition allowed. No **Shotgun bird shot** allowed. No black powder.
16. **CEASE FIRE:** On this command, unload your weapon; open action, lay weapon down and step back from the line. Do not move back into the booth for any reason until cleared by a range officer.
17. **Rental firearms must use GGGR range ammunition only** and returned empty with the action locked open.
18. **Clean up after yourself.** Remove brass off the tables and flip brass forward of the firing line with Hockey Stick.
19. Remember, you are one of the Good Guys, if unsafe behavior is noticed, then please make sure that the Range Officer is notified of such action immediately.
