Note: An AMA Faxed Membership number will be accepted as long as it is on the official AMA Fax notification of membership form. **YOU MUST PROVIDE US WITH YOU AMA NUMBER AT TIME OF APPLICATION.**
2. Failure to keep your AMA membership current will result in revocation of your flying privileges until proof of membership is presented to a club officer.
3. Hold Harmless Agreement below must be read and signed below with the dues to be paid with the application.
4. Applicant must adhere to all Club Rules and Regulations on CCRCC Website.
5. Applicants who have not moved to "Signed Off" Pilot status agree never to fly without the presence and assistance of a Full club member. **FAILURE TO DO SO WILL RESULT IN IMMEDIATE EXPLUSION FROM THE CLUB.**

### CCRCC Release and Hold harmless Agreement

I wish to participate in activities offered by Central Connecticut Radio Control Club, Inc. (hereinafter referred to as 'CCRCC'). I RECOGNIZE THAT ANY CCRCC ACTIVITIES MAY INVOLVE CERTAIN DANGERS. I certify that I am aware of all of the inherent dangers of CCRCC activities including but not limited to: weather conditions, inexperience, accidents or illness in remote areas without medical facilities, the actions of any other member, any participants or any other persons, all of which may result in personal injury, including death, property damage, or other losses.

In consideration for the right to participate in CCRCC activities, I HEREBY RELEASE AND HOLD HARMLESS CCRCC AND ITS DIRECTORS, OFFICERS, INSTTTTSTRUCTORS, AND MEMBERS FROM ANY AND ALL LIABLILITY, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR IN ANY WAY CONNECTED WITHMY PARTICIPATION IN ANY CCRCC ACTIVITIES AND FUTRHER AGREE TO RELEASE AND HOLD HARMLESS CCRCC AND ITS DIRECTORS, OFFICERS, INSTRUCTORS, AND MEMBERS FROM ALL LIABLILITY, CLAIMS AND CAUSES OF ACTION WHICH I MAY HAVE ARISING FROM MY PARTICIPATION IN CCRCC ACTIVITIES. The terms of this agreement will serve as release and hold harmless for my heirs, personal representatives, and for all members of my family, including minors.

CCRCC, as a charter club of the Academy of Model Aeronautics (hereinafter referred to as 'AMA') and its membership being AMA members agree to accept any and all direct liability claims to the limits provided by AMA and their liability insurance coverage. I further state that I am (18) years of age or older and legally competent to sign this release and hold harmless agreement, that I understand these terms are contractual and not merely recital, and that I have signed this document as my own free act.

**(Parents or legal guardians must sign for all persons under (18) years of age).**

I HAVE BEEN INFORMED OF THE CONTENTS OF THIS RELEASE AND HOLD HARMLESS AGREEMENT BY READING IT BEFORE SIGNING IT.

Any guest operation radio control aircraft or helicopters must be a current AMA member and must sign this agreement before flying at the CCRCC facility. Any guest not a current member of AMA must sign the agreement and **MUST FLY ON A BUDDY BOX WITH A CCRCC LICENSED AMA INTRO PILOT.**
