1. Approval of Agenda:

2. Approval of Minutes:

3. Treasurer Report: none

4. Fieldhouse:

- a. Garage update two weeks ahead of schedule should be done first week of July
- b. Garage budget allocated \$150000 currently at \$139952.87 which includes fixing damage to grass area during construction between the rink and garage. We will need a paved path from rink to garage for Zamboni and current contractor has given us a quote for recycled pavement pathway 16ftx100ft for \$5627+gst.

Motion by Chrissy to spend excess/saved budget (as long as budget remains under allocated amount) to have pathway installed between rink and garage for \$5627+gst or less. Motion seconded

by Jessica. All voted in favour and motion passed. Chrissy to get other bids and proceed with best bid.

- c. Internet- Axia cheque annual payment for 2017 which was paid as contract with them was found but they are not willing to provide us internet so Andrew to research other companies
- d. Energy Efficiency Rebates discussed but not helpful as need to pay first and then rebates and fieldhouse was already upgraded last year.
- e. Synergy Trailer Discussed best location and proposed to have trailer behind field house away from tree and water tap. Heather to inform Synergy

- a. Policy and procedure was discussed and Corrie to contact company for quote to revise/create policy, mission statements and visions and bring back to board for discussion.
