**POOL RENTAL REGULATIONS**

**The pool may be rented by the members for their own personal use at any time the pool is not scheduled to be open for the general membership and or the Pinebrook Swim Club, Swim Team. Pool rental is subject to the following conditions:**

- a. Pinebrook must receive pool rental request two (2) weeks prior to the requested party dates for approval at above address. Rental fee must accompany the rental form. If your requested date is not available, your rental fee will be refunded. If two or more rental requests forms are submitted for the same date, the rental form with the earliest postmark will be given first priority.
- b. Anyone renting the pool must agree to abide by the **Swim Club Rules** of Pinebrook and is responsible for any damages to the pool, facilities, and or property caused by any member or guest participating in the party. The renting member dues must be paid in full and all safety and medical forms completed prior to requesting pool rental.
- c. Pool Party Request form must be completed and payment made to pH Pool Management for lifeguards.
- d. The pool rental fee is **\$150.00**. for up to 75 guests, for a two (2) hour party up to a maximum of seventy-five (75) guests. A dditional guest fees are \$50 per 25 guests.
- e. The total number of attendees must be submitted along with the rental request form. (NO EXCEPTIONS)
- f. Guest Liability Waivers must be completed for each non-Pinebrook member attending
- g. **ABSOLUTELY NO ALCOHOLIC BEVERAGES ARE PERMITTED ON THE PINEBROOK SWIM CLUB PROPERTY AT ANY TIME.**

I, the undersigned, as a member of Pinebrook Swim Club, understand and acknowledge that the Pinebrook Swim Club Staff and Board of Directors will do everything to ensure that they party attendees have a safe swimming environment. As a member of Pinebrook, I, the undersigned acknowledge that I have reviewed and understand the Pinebrook Rules. I, the undersigned, acknowledge that I will make Pinebrook rules known to the attending guest prior to the commencing of the party and I will be totally responsible for the actions of the party guest(s). I understand and acknowledge that Pinebrook Staff and Board of Directors will not tolerate unsafe behavior by any attending member or guest. I further acknowledge and understand that Pinebrook Staff and Board of Directors have the right to suspend and/or cancel the party until such time the unsafe situation is corrected. I understand and acknowledge that should the party be suspended and/or canceled for any unsafe situation caused by any member(s) or guest(s), I WILL NOT receive a refund of the pool rental fee. I, the undersigned, agree not to hold Pinebrook Swim Club Staff Member or Board of Directors responsible for any injuries sustained at Pinebrook Swim Club facilities and/or grounds by any attending member(s) and or guest(s) of the party.
