### **GARAGE "HOPPING"**

Homeowners beware! There is a new and illegal activity that is on the rise in our subdivision. Unsupervised kids with cell phones are on the prowl for open garages. An increase in garage theft has occurred mainly in the Village Homes where garages are rear entry. Reports of alcohol, cigarettes and valuables have been reported missing; bikes are also a common theft. Please remember to keep your garage doors shut and doors locked when not in use. Neighbors please keep your eyes open for groups of kids darting in and out of garages and report it to the sheriff's department immediately at (765) 423-9388.

### PET OWNERS

"All pets shall remain under the control and supervision of an adult Owner, and shall not be permitted off of such Owner's respective Lot unless on a leash or other restraint." (CC&R Section 7.5) Many residents in the Village are letting their pets out unsupervised for bathroom breaks and letting them roam. If you are a renter and have a pet, please talk to your landlord about installing an ACC approved fence. The U.S. Center for Disease Control and Prevention (CDC) confirms pet waste can parasites including hookworms, spread ringworms, tapeworms, salmonella and more. When the infected waste touches your lawn the parasitic eggs can linger for years even after the waste is gone! When a human or animal comes into contact with that soil through everyday activities like walking, gardening or playing, they risk infection even years after the waste is gone. Homeowners that have an excess of excrement in their yards will be cited for unclean and unhealthy conditions. (CC&R Section 7.7) This is a health and safety risk to vou and the community, so please pick up after your pet in order to reduce the spread of disease especially along the TPA trail and other common areas!!

# HOLIDAY LIGHT POLICE

For those of you decorating for Christmas 2014, please take down your lights... we still have another eight months until Christmas! Seriously, though, the ACC Committee understands that this winter was a wicked one. However, now that warmer weather is around the corner, please remove your decorations. Violations will be sent out this month for homes not maintained in a manner consistent with the general appearance of the Neighborhood. (CC&Rs Section 7.7) What does that mean? If you have a ton of weeds in your yard, grass to your knees or Christmas decorations still up; you are not consistent with the general appearance of the neighborhood. Thank you for maintaining your lot; it helps make our community look great!


