Supervisor Lindsey Horvath was elected to the Los Angeles County Board of Supervisors and assumed office on December 5, 2022, after serving as a City Coun-

cilmember and the longest consecutively serving mayor for the City of West Hollywood. Her career has been defined by tackling the hardest problems, building diverse coalitions, and delivering results for her community. She made history as the youngest woman to ever be elected to the LA County Board of Supervisors. She is the first millennial and currently the only renter to serve on the board, bringing a much-needed perspective to county leadership.

Supervisor Horvath worked on many transportation and mobility issues, from her service as a Transportation Commissioner to championing Metro transit projects in West Hollywood. She spearheaded policies to make West Hollywood an "Age-Friendly Community" and created the first-ever West Hollywood Community Response Team to Domestic Violence.

### THE DANGEROUSLY HOMELESS

We have heard a lot of talk about the "criminalization of homelessness" and how it is not ethical to throw people in jail just for being homeless. It's easy to agree with this proposition and most of us do. But, agreeing that being homeless is not a crime in and of itself does not change the reality that homeless people commit crimes too. Being homeless does not exempt people from having to follow our laws. If a throng of teenagers were blocking the entrance to a local business while drinking alcohol and harassing and accosting customers ... you better believe the police would remove them. Of course, the teenagers have somewhere to go. The homeless don't. Hence, the problem.

There can be no question that new housing is desperately needed in LA. And it certainly appears that our elected officials are focused on addressing the problem. Seeing it and being willing to do something about it are indispensable prerequisites for fixing it.

**But what about the homeless that refuse to move into housing?** The ones that for various reasons prefer to be on the street? A recent study by the Rand Corporation cited in a January 26, 2023 LA Times article reported that 80% of homeless people, when asked if they would accept housing, replied "yes". This means that 20% of the homeless would refuse housing. Building more housing will not address their problem.

If there are approximately 70,000 homeless in Los Angeles (see LAHSA 2022 homeless count) and 20% of them will refuse to "go inside" this amounts to 14,000 homeless individuals who chose to live on the street. Addressing this problem, fixing this issue, needs to be a top priority.

Over the past several years, the City of Los Angeles has become one of the poster children representing the homelessness crisis in America. To a lesser extent, Sherman Oaks has become the first stop sign at the three-way intersection of tragedy that is played out on our streets: 1) a mental health crisis that fuels homelessness; 2) a political morass (lack of process to create housing and provide mental health services); and 3) a mélange of contradictory laws that fail to empower the city with the authority to force people off the streets when they refuse housing.

To be sure, the road to fixing this problem is laden with unique and vexing challenges. No one would suggest a simple or obvious "fix" to the problem in general. However, specifically addressing the issue of the dangerously unstable homeless – the homeless who pose a threat to themselves and others, and who refuse to "go inside" – needs to move to the very top of our elected official's priority list. The sanctity of everything that we fight for as Sherman Oaks Homeowners is at stake.

### ANOTHER STATE BILL TO CAREFULLY WATCH

Another legislative year has begun and so far, we are watching **Senate Bill 4** introduced by Senator Scott Weiner. This bill would **allow religious and teaching institutions to build affordable housing and shelters on their properties**. This is a repeat bill that was introduced two years ago but failed to pass.

We have always been in support of affordable housing and shelters. But the senate must amend this bill so the allowed housing can only be built on an institution's main campus – and cannot be built in single-family neighborhoods where many of these religious and teaching institutions own single-family homes. It is well known that many people "will" their homes to their place of worship or alma mater, and these institutions often buy homes in single-family neighborhoods for their staff. These homes should not be available for shelters.

Similarly, City of LA Motion 22-0158 also introduces the right to build shelters on campuses of religious institutions. Again, we have sent a letter to the city clerk stating we are in support as long as these shelters are on the institution's main campus. The motion should not include homes owned by these institutions that might be away from their main campus and in single-family neighborhoods.

We believe we all must work together to get more affordable housing in our community and that this can be achieved without building apartments or shelters in our single-family neighborhoods. We will keep you posted. Please contact Maria Kalban at mpkalban@gmail.com with questions.

# METRO OPEN HOUSE ON SEPULVEDA PASS TRANSIT NOT SO OPEN

January was Metro open house month for the Sepulveda Pass Transit Project. SOHA's Bob Anderson attended the Saturday January 21st open house in Van Nuys hoping to learn a lot more about the project. Metro showed some new station information but not much else. Through judicious questioning of Metro personnel, we learned that:

- Metro has delayed publishing the project's Draft Environmental Impact Report by two years to the "latter part of 2024". This is a ridiculous slip but typical Metro – hurry up and wait!
- Metro has delayed the project selection decision by two years to hopefully the end of 2024. But this gives us more
  time to fight now for affordable alternatives that best serve communities along the route.
- Metro has updated the peak passenger capacity for the monorails to 16,560 passengers per hour in each direction (Metro Alternatives 1, 2, and 3). This is 35% more passenger capacity than any of the heavy rail subways which only carry 12,240 passengers per hour (Alternatives 4 and 5) and 11,970 passengers per hour (Alternative 6).

Metro did show new location diagrams for all stations but didn't show any renderings of what the stations might actually look like. That's important to communities and was sadly missed.

Metro provided NO information about construction costs, operation and maintenance costs, financing, affordability, project schedules, construction timelines, public-private partnerships, route details, travel times, station parking, maintenance facilities, eminent domain, tunneling impacts, elevated train impacts, noise, or safety.

The public needs much more information - NOW! In two years, we will have only a month or so to review and comment on a 1,000-page or more Draft Environmental Report. By that time, we'll have had no substantive project information from Metro for four years. How can Metro reasonably expect people to read 1,000+ pages and make good comments in a month? Metro - get real and give the public information now. Stop the silly dog and pony shows. Be collaborative, not combative. Be informative, not misinformative. Work with us, not to spite us.

### METRO HIDES AGAIN BEHIND FREEWAY DIGITAL BILLBOARDS

Jay Weitzler notes that transparency is not the favorite way for Metro to operate, so without any public outreach whatsoever, it appears that they have approved the installation of 97 changing digital billboards towering over 16 commercial corridors and 8 different freeways across LA County, including the Ballona Wetlands Ecological Reserve and additional sensitive locations.

Although Metro is clearly involved in planning transportation countywide, they seem to be unconcerned in the least about safety and more concerned about a money grab from renting billboard space. Had Metro held public hearings, they would have been properly informed about the risk to drivers from looking at changing billboards while going 70 mph on the freeway or driving on other highly traveled streets.

But, as we have learned in studying the "plans" for the Sepulveda Transit Corridor, listening to their constituency is not the way Metro works. Please let City Councilmember Nithya Raman (contactCD4@lacity.org) and County Supervisor Lindsey Horvath (ThirdDistrict@bos.lacounty.gov) know that this is not what we expect of our officials.
