WHEREAS, having such an agreement for exception of matters which are not of an intermunicipal or county-wide concern is not detrimental to the County or the Town of Hampton Town Board; and

WHEREAS, the Washington County Planning Board has established a process for exempting matter and actions of local concern from the referral requirements of GML 239; now, therefore, be it

from the referral requirements of GML 239 shall exist between the County Planning Board and the Town of Hampton Town Board; and be it further

The Town Board hereby declares that this action is an "Unlisted Action" to 6 NYCRR 617 et. seq., and after reviewing the environmental assessment form included with the information before the Town Board on the said Local Law, the Town Board has determined that the adoption of the Local Law will not have an adverse impact on the environment; and
